## Celebrating Rail Safety Month in California

California's extensive railroad and rail transit systems play a crucial role in our state's transportation infrastructure, which is on the forefront of many exciting advancements. The California Public Utilities Commission (CPUC), which is responsible for ensuring safe operations and structural integrity of these systems, this month celebrates Rail Safety Month in California with a commitment to safety and an eye toward the future.

The CPUC holds safety and security regulatory authority over all railroads, rail transit, and rail guideway systems, and all at-grade crossings in California. The CPUC ensures compliance with

state and federal rules and regulations to enhance public safety and operational integrity of rail systems. The CPUC continuously reviews safety plans; conducts inspections of infrastructure, rail cars, locomotives, and rail transit vehicles; and investigates derailments and accidents. The focus is on identifying regulatory non-compliance, safety concerns, risks, and unsafe acts or conditions to ensure the well-being of passengers and workers.

The rail industry is poised for significant advancements and innovations that could redefine the way Californians travel. With these innovations on the horizon, the CPUC's role in ensuring

safety and overseeing the implementation of new technologies becomes even more critical. Developments on the horizon include:

- **INSTRUMENTED TRACK INSPECTION DEVICES AND SMART SENSORS:** These technologies will enable more accurate and efficient track maintenance and safety monitoring.
- **HIGH-SPEED RAIL SYSTEMS:** California's two ambitious high-speed rail projects promise faster and more sustainable transportation options.
- **MAGLEV HIGH-SPEED RAIL SYSTEMS:** Magnetic levitation technology could lead to even faster and smoother rail travel.

## CPUC Now Accepting Applications for New \$30 Million Equity and Access Grant Program

The CPUC is now accepting applications for its groundbreaking \$30 million [Equity and Access Grant Program](#). This innovative program aims to empower tribes and community-based organizations across California by supporting their active engagement in CPUC processes and by promoting clean energy programs. The CPUC [introduced this program earlier this summer](#), with funding allocated by the Legislature. The program has already drawn strong interest, with more than 430 participants attending a recent workshop dedicated to the program.

In this first round, applicants can apply for two of the three grant categories, which include:

1. **PUBLIC PARTICIPATION GRANT:** This grant removes financial and public participation barriers, providing up to \$15,000 to support engagement in CPUC activities such as working groups, panels, or focus groups. A total of \$3.1 million is available for this initiative. Applications will be accepted until June 30, 2025, or until funds are exhausted.
2. **EQUITY, ENGAGEMENT, AND EDUCATION GRANT:** This grant enhances the capacity of Tribal and community-based organizations to engage with the CPUC and its decision-making processes, leading to better informed policy that ad-

resses the needs of vulnerable communities. The program offers up to \$200,000 for projects focused on educating consumers or conducting outreach within underserved communities regarding CPUC matters. A total of \$9.75 million is available for this initiative, with round one applications accepted until Oct. 31, 2023.

The third category, the **CLEAN ENERGY ACCESS GRANT ACCOUNT**, which will award grants up to \$500,000 for work to address access to or education about the CPUC's [Microgrid Incentive Program \(MIP\)](#), [Self-Generation Incentive Program \(SGIP\)](#), and the [Technology and Equipment for Clean Heating Initiative \(TECH\)](#), will open for applications starting in late 2023/early 2024.

The Equity and Access Grant Program aligns with the CPUC's Environmental and Social Justice (ESJ) Action Plan. It creates opportunities for ESJ and Tribal communities to engage in CPUC proceedings, ensuring equitable access to clean energy resources, transportation, and communication services for all Californians.

# CPUC Land Conservation Legacy: Safeguarding California's Wilderness

California's natural beauty and abundant resources have always been a source of pride. Ensuring the preservation of these resources is part of the CPUC's continued efforts to impact land conservation throughout the state.

The CPUC has achieved a legacy of long-term land preservation through a 2004 settlement with Pacific Gas and Electric Company (PG&E) that required the utility to not only create the Pacific Forest and Watershed Stewardship Council (Stewardship Council) but also provide funding of \$100 million—\$70 million for land planning and enhancements, known as the Land Conservation Commitment (LCC), and \$30 million dedicated to youth educational programs.

The CPUC made a recommendation this year to donate additional land to the California Department of Forestry and Fire Protection (CAL FIRE) and the University of California, Berkeley Forests (Berkeley Forests), which marks a crucial milestone in the CPUC's land conservation efforts.

These allocations will have a significant impact on California's land use and conservation efforts.

## Land Donations to CAL FIRE

Approximately 15,000 acres of land was donated to CAL FIRE in various locations, including Battle Creek, Bear River

(Bear Yuba Land Trust and Placer Land Trust), Cow Creek, Lake Spaulding, Pitt River, and Tunnel Reservoir. This [donation](#) was aimed at expanding the Demonstration State Forest system, which serve as a living laboratory for how to care for and manage California's forest lands for multiple benefits.

In 2019, CAL FIRE also received a 1,052-acre parcel of land at the North Fork Mokelumne River. The Shasta Land Trust holds a conservation easement over some of the lands donated to CAL FIRE as well. This significant step contributes to the protection of California's forest resources and environmental sustainability for current and future generations.

## Land Donations to Berkeley Forests

[Berkeley Forests](#) was granted land parcels to further its research and conservation efforts. In 2015 and 2016, Berkeley Forests received approximately 1,500 acres in the Narrows and Lake Spaulding areas.

The land donation will help Berkeley Forests operate a network of five research forests across the state to develop and test appropriate management strategies for forested watersheds that will flourish under different climate change scenarios. One of its core objectives is to address the critical issue of wildfires in California. Recognizing the significance of fire in various ecosystems and the challenges posed by human development in fire-prone areas, their mission centers on fostering a sustainable coexistence with wildfires. They are committed to the development and dissemination of science-based solutions to tackle the complex challenges posed by wildfires, emphasizing the importance of understanding and managing fire in California's unique landscape.

These land allocations reflect a commitment by the CPUC to the preservation and responsible management of California's natural resources, while also supporting research and recreational opportunities that will benefit all Californians.

The [Stewardship Council](#) has nearly completed its work and the Sierra Nevada Conservancy (a California State Agency) was appointed by the CPUC to administer the remaining funds following the dissolution of the Stewardship Council. ■



# CPUC Commissioner Karen Douglas Confirmed by State Senate

Commissioner Douglas was [appointed](#) to the CPUC by Governor Gavin Newsom on Dec. 22, 2022.

“It is my privilege to serve the people of California at the CPUC. I thank the Governor and the Senate for this opportunity,” said Commissioner Douglas. “I look forward to continuing my work overseeing essential services that Californians rely on every day.”

Prior to her appointment to the CPUC, Commissioner Douglas

served as the Senior Advisor for Energy in the Office of Governor Newsom since 2022. She was a California Energy Commission member from 2008 to 2022, and she was Director of the California Climate Initiative for the Environmental Defense Fund from 2005 to 2008. She held several positions at the Planning and Conservation League from 2001 to 2005, including Acting Executive Director and General Counsel. Commissioner Douglas earned a Juris Doctor degree from Stanford Law School and a Master of Public Policy degree in Environmental Policy from the University of Colorado Boulder. ■
