General Rate Case Application (A.22-07-001)

April 11, 2023

What is this Rate Application About?

Every three years, the California Public Utilities Commission (CPUC) requires California-American Water Company (Cal-Am) to file a General Rate Case (GRC) application. Pursuant to this requirement, on July 1, 2022 Cal-Am filed Application (A) 22-07-001 requesting an increase in revenues for 2024, 2025, and 2026. Subsequently, in response to new legislation, Cal-Am requested an opportunity to update its application to propose a decoupling mechanism, the Water Resources Sustainability Plan (WRSP), as an alternative to the Monterey-Style Water Revenue Adjustment Mechanism (M-WRAM) contained in its original application.¹

Cal-Am was granted permission and on January 27, 2023 filed its Updated Application. In its Updated Application, Cal-Am also incorporated recent approved rate changes and revised demand forecasts. This Fact Sheet reflects the numbers in Cal-Am's Updated Application.

This application allows the CPUC to take a broad, in-depth look at Cal-Am's income and expenses and consider quality of service and other factors, and then decide whether to raise or lower Cal-Am's rates, and whether to require other changes in Cal-Am's operations.

What Increases in Revenue is Cal-Am Requesting to be Funded Through Customer Water Bills for the Period of 2024-2026?²

California American Water is requesting a Northern Division revenue increase of \$14,560,700 or 17.10% in 2024, \$8,671,000 or 8.55% in 2025, and \$8,739,500 or 7.93% in 2026 under the WSRP proposal. Under the M-WRAM proposal, California American Water is requesting a revenue increase of \$13,981,200 or 16.31% in 2024, \$8,661,900 or 8.53% in 2025, and \$8,739,200 or 7.93% in 2026.

² The amount of revenue to be authorized is based on the forecasted operating and capital costs of doing business. This, combined with forecasted water sales and number of customers, produces the necessary changes in rates.











¹ Senate Bill 1469, adopted September 30, 2022, amends Section 727.5 of the Public Utilities Code to require the Public Utilities Commission to consider for authorization the implementation of a mechanism that separates a water corporation's revenues and its water sales.

What Types of Additional Costs Does Cal-Am Say it Needs to Recover?

Cal-Am is requesting to recover costs for proposed new capital investments to replace and upgrade its water system and facilities as well as for additional administrative, general, and labor costs. Cal-Am's application requests:

- Infrastructure Improvements: \$11 million 3-year capital expenditure budget increase for capital investments in facility retirements, improvements, and replacements; replacement wells; and improved water treatment systems
- Small System Consolidation Support: \$1.6M to consolidate small water systems with California-American Water
- Employee Labor Costs: \$1.3 million increase for staffing, wages, and benefits
- Inflationary Increases: \$2.3 million increase for inflationary costs
- Increased Depreciation: \$3.1 million for increased depreciation

WRSP vs. M-WRAM:

• As an alternative to the Monterey-Style WRAM (Water Revenue Adjustment Mechanism), Cal-Am proposes to implement the WRSP (Water Resources Sustainability Plan), composed of a decoupling balancing account, Annual Consumption Mechanism, amortization schedule, and rate design modifications
