
Water Cost of Capital Application (A.23-05-001)

November 9, 2023



Every three years, the California Public Utilities Commission (CPUC) requires San Gabriel Valley Water Company (San Gabriel) to file a Cost of Capital (CoC) application. Pursuant to this

How Much Will San Gabriel's Revenue Increase?

The total increases in San Gabriel's request are \$2,290,000 or 2.5% for the Los Angeles County Division and \$2,200,000 or 2.4% for the Fontana Division beginning January 1, 2024.

Under San Gabriel's request, an average residential customer in the LA County Division with a 5/8-inch meter using 12 CCF (1 CCF = 748 gallons) would see a bill increase from \$77.38 currently to \$79.45 per month. That is an increase of \$2.07 or 2.7%. An average residential customer in the Fontana Division with a 5/8-inch meter using 15 CCF (1 CCF = 748 gallons) would see a bill increase from \$84.60 currently to \$86.56 per month. That is an increase of \$1.96 or 2.3%.



What Other Rate Requests Are Pending?

San Gabriel has a pending application regarding their General Rate Case (A.22-01-003) where they are seeking a rate increase of \$10,791,000 or 13.1% for the LA County Division and \$9,202,000 or 11.3% for the Fontana Division beginning July 2023.

How Can I Have My Voice Heard And Find Out More?
