Program Overview

- In 2017, AB 1665 the "Internet for All Now Act" amended the statutes governing the CASF program, Public Utilities Code, § 281 and 914.7.
- The Commission issued D.18-12-018 adopting the programmatic changes to the CASF.
- Appendix 1 of D.18-12-018 set forth the rules, application requirements and guidelines for the CASF Infrastructure Account.
- \$300 Million in funding available.





Program Goals

- Provide broadband access (at least 6 Mbps download/ 1 Mbps upload) to no less than 98% of households in each consortia region as identified by the commission on or before January 1, 2017.
- Goal Achieved:
 - Bay Area (no consortium: SF, San Mateo, and Santa Clara)
 - East Bay Broadband Consortium
 - Los Angeles County Regional Broadband Consortium
- Highest Levels of Unserved Households:
 - Inyo/Mono Broadband Consortium (17.6%)
 - Upstate California Connect Consortium (14.9%)
 - Eastern Sierra Connect Regional Broadband Consortia (9.1%)
 - Redwood Coast Connect Consortium (8.7%)





Who May Apply

Entities eligible to apply for a CASF Infrastructure grant:

- Entities with a Certificate of Public Convenience and Necessity (CPCN).
- Wireless carriers who are registered with the Commission (i.e. hold a Wireless Identification Registration).
- Non-telephone corporations that are facilities-based broadband service providers (using the National Telecommunications and Information Administration's definition of facilities-based broadband service provider).
- A local governmental agency if no other eligible entity applied (including sovereign tribal governmental entities).
- Satellite service providers who are able to meet the minimum performance criteria.





Project Eligibility

To be eligible, a project must meet the following:

- Area defined as unserved by existing facilities-based broadband provider (Less than 6 Mbps Download / 1 Mbps Upload).
- Connect America Fund Phase II (CAF II) areas are ineligible until July 1, 2020.
- Middle-mile infrastructure must be indispensable to accessing the last-mile infrastructure.
- Capable of offering broadband service at or above 10/1 Mbps, irrespective of technology.
- Previous CASF Areas are eligible for new funding 3 years from the start of broadband service of the first-CASF funded project.





Funding Criteria

- Public Utilities Code, § 281 (f)(13) allows the Commission to fund all or a portion of a project on a case-by-case basis.
- The funding level considers the following factors:

Maximum Funding Level: 100%

Baseline for Eligible Project (60%)

Service Level Preference: Only Dial-up or No Internet Connectivity (40%)—no fixed or mobile broadband

Low Income - up to 40%

- Median Household Income for community is less than CARE standard for family of 4, which is currently \$52,400 (30%)
- Applicant serves low-income customers for no more than \$15/month (10%)

Others: PU Code Sec 281 (f)(13) Criteria - up to 20%

- Inaccessible Location (10%)
- Uses Existing Infrastructure (10%)
- Makes a Significant Contribution to the Program Goal (10%)





Performance Criteria

Commission approved projects must:

- Complete construction within
 - 24 months after authorization to construct (CEQA Approval)
 - 12 months (CEQA Exempted)
- Provide speeds of at least 10 Mbps Download / 1 Mbps Upload
- Latency not to exceed 100 ms
- Data Caps shall provide a minimum of 160 GBs per month
- All projects shall provide an affordable broadband plan for lowincome customers
- Pricing commitments for 2 years after project completion





How to Apply

- Contact and work with your local Consortia.
- Utilize the Interactive Broadband Map.
 - Applications will be evaluated based on information found in the Interactive Broadband map.
 - Application Tool (within Interactive Broadband Map).
- A CASF Infrastructure Grant Application must be submitted by each applicant for any eligible project areas.
 - Non-contiguous project areas may be considered as a single project.

Potential Rule Changes


