**AMENDED APPLICATION OF SOUTHERN CALIFORNIA EDISON  
COMPANY (U 338-E) FOR A PERMIT TO CONSTRUCT ELECTRICAL FACILITIES  
WITH VOLTAGES BETWEEN 50 KV AND 200 KV: CONSOLIDATED VALLEY-  
IVYGLLEN 115 KV SUBTRANSMISSION LINE PROJECT AND FOGARTY  
SUBSTATION PROJECT**

On January 16, 2007, Southern California Edison Company (SCE) filed Application No. 07-01-031 pursuant to General Order 131-D (GO 131-D) for a Permit to Construct (PTC) the Valley-Ivyglen 115 kV Subtransmission Line Project. On April 30, 2007, SCE filed Application No. 07-04-028 pursuant to GO 131-D for a PTC for the Fogarty Substation Project. A Proponent's Environmental Assessment (PEA), which addresses each of the California Environmental Quality Act (CEQA) factors, was attached to the applications for both of these projects. SCE noticed the filing of both of these applications to certain public agencies, legislative bodies and property owners located within 300 feet of the proposed projects in accordance with GO 131-D, Section XI.A.

On June 7, 2007, the Administrative Law Judge (ALJ) issued a ruling consolidating the Valley-Ivyglen 115 kV Subtransmission Line Project and the Fogarty Substation Project into a

single project (Proposed Project). The ALJ ruling also ordered SCE to serve an amended notice of the consolidated applications as required by GO 131-D, Section XI by June 15, 2007.

Pursuant to the ALJ's ruling, SCE served the amended notice as required by GO 131-D, Section XI on June 15, 2007.

Subsequent to the ALJ's ruling consolidating the Valley-Ivyglen 115 kV Subtransmission Line Project and the Fogarty Substation Project into a single project, the Energy Division requested SCE to revise the Project Alternatives, Project Description, and Other CEQA Considerations sections from the PEAs to reflect the consolidation of the applications. On August 31, 2007, SCE provided the Energy Division with a revised Project Alternatives section, Project Description section, and Other CEQA Alternatives section for the Proposed Project. At this time, pursuant to the Commission's Rules of Practice and Procedure Rule 1.12(a), SCE hereby amends A.07-01-031 and A.07-04-028 with the information attached hereto.
