Hello, Jody:

On behalf of PG&E, please find attached materials fulfilling the requirements of APM AQ-3 for the HDD work, NTP 2. The attached pdf includes the approved Asbestos Dust Mitigation Plan, as well as a copy of the BAAQMD approval of that plan.

APM AQ-3: Minimize Potential Naturally Occurring Asbestos (NOA) Emissions. The following measures will be implemented prior to construction:

- Prior to commencement of construction, samples of the Potrero Switchyard construction area will be analyzed for presence of asbestos, serpentinite or ultramafic rock
- For disturbed areas of greater than 1.0 acre, submit an Asbestos Dust Mitigation Plan to the BAAQMD and obtain approval prior to commencement of construction
