



## Gavin Newsom

Gavin Newsom has championed innovative public programs since first taking office in 1997.

As a member of the San Francisco Board of Supervisors, then as mayor of San Francisco and now as Lieutenant Governor of California, Newsom has been a visionary on issues of equality, the environment, homelessness and healthcare. Policies he has initiated and implemented have been duplicated in cities across the nation.

During his seven-year tenure as mayor, he led San Francisco to an economic recovery by making the city a center for biotech and clean technology, while attracting and then keeping start-ups. As mayor, he established aggressive goals to reduce carbon emissions, increase municipal energy efficiency and the use of alternative fuels.

In 2010, Newsom was selected the greenest mayor for a second year in a row. Shortly after he established the most stringent green building standards in America.

As Lieutenant Governor, Newsom continues his environmental work as a member of the State Lands Commission, protecting California's most precious natural resources while balancing use of lands, waterways and ports.

In addition to his certification, Doug is a technical advisor to the State of California's Green Collar Jobs Council. Currently, Doug serves as co-chair of the statewide management team for the California Advanced Lighting Controls Training Program, (CALCTP). As one of the main leaders in the creation of this Green Energy Job's Creation program that was funded in partnership with IBEW/NECA, the State of California, UC Davis's California Lighting Technology Center (CLTC), PG&E, Sempra, SMUD, the California Community Colleges, and the lighting and controls industry.
