

**NOTICE OF PUBLIC PARTICIPATION HEARING:
CALIFORNIA WATER SERVICE'S REQUEST TO INCREASE RATES IN ITS
GENERAL RATE CASE APPLICATION NO. A.15-07-015
WILLOWS SERVICE AREA**

April 26, 2016 • 6:00 p.m.

The California Public Utilities Commission (CPUC) wants to hear from you. A Public Participation Hearing (PPH) has been scheduled for customers in the Willows District at the date, time, and location noted above to receive your comments about California Water Service's (Cal Water) General Rate Case (GRC) application (A.15-07-015). A CPUC Administrative Law Judge (Judge) will preside at the PPH to listen to concerns, comments, and opinions on the proposed application.

The hearing location is wheelchair accessible. If you need a language translator or special assistance, please contact the CPUC's Public Advisor's Office (PAO) at the address listed at the bottom of this notice at least five days in advance of the hearing date. If you cannot attend the PPH, you may submit your comments via a letter or email to the PAO.

Cal Water's Application: Every three years, Cal Water is required to file a GRC with the CPUC. On July 9, 2015, Cal Water filed its 2015 GRC application (A. 15-07-015) requesting approval to increase rates so that water rates reflect the cost of providing water service. Also included in A.15-07-015 is Cal Water's proposal to gradually merge the costs of its Chico, Marysville, Oroville, and Willows Districts to improve affordability and develop administrative efficiencies.

A. With Cost Consolidation If this consolidation is approved by the CPUC as proposed, the portion of the requested revenue increase for Willows customers would be \$274,000, or 11.7%, for 2017, \$72,000, or 2.7%, for 2018 and \$71,000, or 2.6%, for 2019. With consolidation, the total revenue increase over the three years would be \$417,000 or 17.7%.

Typical Customer Impact with Consolidation If Cal Water's proposed consolidation of the Chico, Marysville, Oroville, and Willows Districts is approved, the bills for a typical residential customer in Willows with a 5/8" x 3/4" meter using 9,725 gallons (13 Ccf) of water per month would resemble those below. **These numbers do not include surcharges and credits.**

B. Without Cost Consolidation If consolidation is not approved, Cal Water requests revenue increases for its Oroville District of \$975,000, or 41.5%, for 2017, \$48,000, or 1.4%, for 2018 and \$109,000, or 3.2%, for 2019. Without consolidation, the total revenue increase over the three years would be \$1,132,126 or 48.2%.

Typical Customer Impact without Consolidation If Cal Water's proposal is adopted **without consolidation**, the bills for a typical residential customer with a 5/8" x 3/4" meter using 9,725 gallons (13 Ccf) of water per month would resemble those below. **These numbers do not include surcharges and credits.**

Reasons for Increase: Cal Water has been providing water to California communities for nearly 90 years, and many of the facilities used for water service have reached the end of their useful lives. For the Willows District, without consolidation, most of Cal Water’s requested revenue increases are made up of the following components:

- Projected operation and maintenance expenses (49%)
- Water infrastructure improvements (47%)
- Supply costs (4%)

Cal Water’s proposed rates for 2017-2019 would become effective on January 1, 2017. The rate increases for 2018 and 2019 are calculated using the most recent inflation factors provided by the CPUC. The CPUC requires that Cal Water use a simplified, inflation-based, escalation methodology for its proposed rates for 2018 and 2019.

The CPUC’s Process

This application has been assigned to a Judge who will determine how to receive evidence and other related documents necessary for the CPUC to establish a record upon which to base its decision. Evidentiary hearings may be held where utilities, consumer advocacy groups, and other entities which have been given official status as “parties” will present their testimony and may be subject to cross-examination by other parties. These evidentiary hearings are open to the public, but only those who are parties may participate. The hearings and documents submitted in the proceeding become part of the formal record that the Judge relies upon when writing a proposed decision to present to the Commissioners for their consideration.

After considering all proposals and all evidence presented during the formal hearing process, the Judge will issue a proposed decision determining whether to adopt Cal Water’s request, modify it, or deny it. Any of the CPUC’s Commissioners may sponsor an alternate decision. The proposed decision and any alternate decisions will be discussed and voted upon at a scheduled Commission Voting Meeting.

As a party of record, the Office of Ratepayer Advocates (ORA) has reviewed this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering.
