**NOTICE OF PUBLIC PARTICIPATION HEARING:  
CALIFORNIA WATER SERVICE'S REQUEST TO INCREASE RATES IN ITS  
GENERAL RATE CASE APPLICATION NO. A.15-07-015  
BAYSHORE SERVICE AREA**

**The California Public Utilities Commission (CPUC) wants to hear from you.** A Public Participation Hearing (PPH) has been scheduled for customers in the Bayshore District at the date, time, and location noted above to receive your comments about California Water Service's (Cal Water) General Rate Case (GRC) application (A.15-07-015).

A CPUC Administrative Law Judge (Judge) will preside at the PPH to listen to concerns, comments, and opinions on the proposed application. One or more Commissioners may attend, but **no decisions will be reached at this hearing**. All public comments from this PPH will be included in the formal record of this proceeding and become public record.

The hearing location is wheelchair accessible. If you need a non-English language translator or special assistance, please contact the CPUC's Public Advisor's Office (PAO) at the address listed at the bottom of this notice at least five days in advance of the hearing date. If you cannot attend the PPH, you may submit your comments via a letter or email to the PAO.

**Cal Water's Application**

Every three years, Cal Water is required to file a GRC with the CPUC to ensure water rates reflect the cost of providing water service. On July 9, 2015, Cal Water filed its 2015 GRC application requesting approval to increase rates by \$94,838,100 (or 16.5%) in 2017, \$22,959,600 (or 3.4%) in 2018, and \$22,588,200 (or 3.3%) in 2019. Also included in this application is Cal Water's proposal to gradually merge the costs of the Bayshore and Redwood Valley Districts to improve affordability and develop administrative efficiencies.

**A. With Cost Consolidation** – If this consolidation is approved by the CPUC as proposed, the portion of the requested revenue increase for Bayshore customers would be \$7,184,000 (or 9.3%) for 2017, \$1,200,000 (or 1.4%) for 2018, and \$1,244,000 (or 1.5%) for 2019. With consolidation, the total revenue increase over the three years for the Bayshore District would be \$9,628,000 (or 12.5%).

**Typical Customer Impact with Consolidation** – If Cal Water's proposed consolidation of the Bayshore and Redwood Valley - Unified Districts is approved; the bills for a typical residential customer in Bayshore with a 5/8" x 3/4" meter using 7,481 gallons (10 CCF) of water per month would resemble those below. **These numbers do not include surcharges and credits.**

**B. Without Cost Consolidation** – If consolidation is not approved, Cal Water requests revenue increases for its Bayshore District of \$6,352,000 (or 8.3%) for 2017, \$1,307,000 (or 1.6%) for 2018, and \$1,306,000 (or 1.5%) for 2019. Without consolidation, the total revenue increase over the three years for the Bayshore District would be \$8,965,000 (or 11.7%).

**Typical Customer Impact without Consolidation** – If Cal Water’s proposal is adopted **without consolidation**; the bills of a typical residential customer with a 5/8” x 3/4” meter using 7,481 gallons (10 CCF) of water per month would resemble those below. **These numbers do not include surcharges and credits.**

**Reasons for Increase**

Cal Water has been providing water to California communities for nearly 90 years, and many of the facilities used for water service have reached the end of their useful lives. For the Bayshore District, most of Cal Water’s requested revenue increases are made up of the following components:

- Water infrastructure improvements (82.4%)
- Projected operation and maintenance expenses (17.6%)

Cal Water’s proposed rates for 2017-2019 would become effective on January 1, 2017. The rate increases for 2018 and 2019 are calculated using the most recent inflation factors provided by the CPUC. The CPUC requires that Cal Water use a simplified, inflation-based, escalation methodology for its proposed rates for 2018 and 2019.

**The CPUC’s Process**

After considering all proposals and all evidence presented during the formal hearing process, the Judge will issue a proposed decision determining whether to adopt Cal Water’s request, modify it, or deny it. Any of the CPUC’s Commissioners may sponsor an alternate decision. The proposed decision and any alternate decisions will be discussed and voted upon at a scheduled Commission Voting Meeting.

As a party of record, the Office of Ratepayer Advocates (ORA) has reviewed this application. ORA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. ORA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering.
