# Guidance on Funding Sources for Federal Funding Account Awardees

June 2025

The last mile Federal Funding Account (FFA) program is funded from the California State General Fund and the federal [Capital Projects Fund](#) (CPF). This document provides instructions for FFA awardees to locate the amount of their project(s) funded with federal CPF funds in the [Broadband Grant Portal](#). This document also provides the required information for FFA awardees with projects funded with federal CPF funds to comply with Single Audit requirements in accordance with Title 2 of the Code of Federal Regulations (CFR) [section 200.332](#).

*The CPUC will provide information to awardees on the source of funds. As projects progress, the funding sources may be updated and awardees should periodically review the “Amount of Federal Funds Obligated” on the Awards page.*

### Amount of Federal Funding

Awardees may locate the amount of their project(s) funded with federal CPF funds in the Broadband Grant Portal. After logging in, go to the Awards page for each project. The amount of an FFA award with a CPF funds component is under the heading “Amount of Federal Funds Obligated” on the Details tab. If an award is not funded with CPF funds or any other federal source of funding, the amount under “Amount of Federal Funds Obligated” will be \$0.

## CPF Award Information

Purpose: The purpose of the Coronavirus Capital Projects Fund (CCPF) is to provide financial assistance to States, Territories, and Tribal governments to carry out critical capital projects that directly enable work, education, and health monitoring, including remote options, in response to the public health emergency with respect to the Coronavirus Disease (COVID-19).

Activities to be performed: Under the CCPF program, Treasury will provide \$10 billion in assistance as grants to State, Territories, and Tribal governments to carry out critical capital projects directly enabling work, education, and health monitoring, including remote options, in response to the public health emergency with respect to the COVID-19.

End Goal/Expected Outcomes: The CCPF will fund investments in eligible capital projects that: 1) Improve communities' physical or remote connectivity by investing in capital assets that directly enable work, education, and health monitoring; 2) Address a need that results from or was exacerbated by the COVID-19 public health emergency; and 3) Address a need for underserved or unserved people.



**Intended Beneficiaries:** The primary intended beneficiaries under the CCPF program are those who face challenges caused by COVID-19, especially in rural America, low and moderate-income communities, including, households, businesses, nonprofit institutions/organizations, and other key public institutions in the eligible entities' jurisdictions.

**Subrecipient [FFA awardees] Activities:** Subrecipients [FFA awardees] may be used by eligible recipients [State of California] to carry out some of the eligible projects under this program.
