The California Public Utilities Commission (CPUC) is seeking to fill vacancies on the California Teleconnect Fund Administrative Committee (CTF-AC). The California teleconnect Fund program (CTF) provides discounted telecommunications and broadband services to eligible organizations across the state.

What is CTF-AC?

Established under Public Utilities Code Section 280(a), the CTF-AC advises the CPUC on the development, implementation, and administration of the program. The committee supports universal service by helping ensure schools, libraries, hospitals, health clinics, and community organizations receive discounted telecommunications services, and to carry out the program under the CPUC's direction, control, and approval.

The CTF-AC meets quarterly where updates on the AC, CTF program, and legislations are shared. The next upcoming quarterly meeting will be on March 2, 2026, which we encourage you to join.

Why You Should Consider Serving on the CTF Administrative Committee

Your perspective is essential to ensuring California's most critical institutions remain connected. By serving on the CTF-AC, you bring the real-world needs of your sector, whether community based organizations, deaf/hard of hearing, education, local exchange carriers, public hospitals, public libraries, or rural Clinics/telemedicine, directly into statewide decision-making. This committee helps shape how discounted broadband and telecommunications services are delivered to organizations like yours, especially those in rural or underserved areas. Your expertise ensures the program remains responsive, equitable, and effective.
