
RDOF Kicker Application – Item 5

Project Summary & Funding Request: Hunter respectfully requests Level 2 RDOF Kicker Funding of 20% of the total annual reserve amounts associated with the below noted areas (census block groups). This 20% level amounts to a total of \$2,381,168.00 in additional funding for these incredibly beneficial projects. The associated project proposes to deploy fiber optic infrastructure within the noted census block groups to provide high-speed Internet service to the Hoopa Valley Tribal Reservation in Humboldt County and surrounding areas. The proposed project will enable broadband access at speeds of up to 1000 Megabits per second (Mbps) to eligible locations as detailed below. The proposed project will provide ancillary benefits, including improved connectivity in a region located in Tier 2 and Tier 3 Fire-Threat Districts as noted on the California Public Utilities Commission's (Commission) Fire Map.

Additionally, Hunter respectfully requests a waiver of the COLR and IRU requirements included under Level 2 support (Requirements 3.a and 3.b under Item 4.2 of R.20-08-021, "Decision Establishing Process for the California Advanced Services Fund to Leverage the Federal Rural Digital Opportunity Fund"). As a non-incumbent competitive provider, Hunter's ability to serve as a COLR in this area would represent an infeasible requirement, burdening the organization with expensive additional build out and network enhancements that could represent long-term damage to Hunter's ability to provide the proposed services as intended on a long-term basis. As a small competitive provider, Hunter is resource limited in comparison to large incumbents and this potential requirement would stretch said resources too thin to be considered reasonable. The IRU requirement included under Level 2 support is unnecessary as the nature and scope of Hunter's planned build and partnership with the Hoop Tribe already represents a significant public benefit—this additional requirement would potentially place an unnecessary burden and obstacle on the existing project plan and associated relationships. Project Scope/Details:

Project includes an estimated 130+ miles of constructed fiber and appurtenances, including underlying infrastructure (poles, conduit, cabinets, POP's, etc.) as needed. Terrain is incredibly restrictive and final pathway engineering will be completed in coming months. Project anticipates utilizing existing middle-mile infrastructure initially, with plans for establishing diverse middle-mile or backhaul pathway and/or interconnect in the future.
