**Subject: Reminder Notice for Annual Reporting Requirements**

The California Public Utilities Commission's (CPUC or Commission) Communications Division (CD) is sending this letter to all telephone corporations (carriers) as a reminder of their obligation to comply with the following annual reporting requirements. Pursuant to Decision (D.) 24-11-003, this reminder notice applies to all Interconnected VoIP service providers including carriers that were migrated to have a DVF or DVN utility type status.<sup>1</sup>

The applicability of the reporting requirements depends on the operating authority or registration approval granted to each telephone corporation (carrier). To ensure that the CPUC has current information for each carrier's primary regulatory contact and official customer complaints contact, carriers must log into **the Telecommunications & User Fee Filing System (TUFFS) portal to review and verify their contact information on or before June 1, 2026**.<sup>3</sup> The carrier contact information must be updated in the Commission's TUFFS portal within 30 days of any change. If there have been no changes to a carrier's contact information within the past 12 months, the carrier is still required to submit a Contact Update in TUFFS annually by June 1, that validates the information is still current. Failure to comply with CPUC rules and requirements may subject the telephone corporation to Commission enforcement actions and/or financial penalties including but not limited to issuance of a citation pursuant to Resolution T-17601<sup>4</sup> and/or revocation of operating authority. **ATTACHMENT A**  
**ANNUAL REPORTING REQUIREMENTS FOR TELEPHONE CORPORATIONS**

**1) ANNUAL TARIFF FILING (DUE FEBRUARY 15, 2026)**

Pursuant to Public Utilities (Pub. Util.) Code Section 489(a), all telephone corporations are required to file their Tariffs with the Commission. To meet this requirement, all utilities subject to the annual tariff filing requirement must complete the CD Compliance cover sheet and attach it to the approved Annual Tariff Filing submission. The Tariff filing requirement is not applicable to Wireless Identification Registration (WIR) holders or to Nomadic-only Interconnected Voice over Internet Protocol (VoIP) service providers. Pursuant to Decision (D.) 24-11-003, no action is required for detariffed carriers.

**2) ANNUAL PERFORMANCE BOND FILING (DUE MARCH 31, 2026)**

Pursuant to D.13-05-035, D.10-09-017, D.11-09-026, and D.24-11-003, all telephone corporations granted operating authority pursuant to Pub. Util. Code Sections 1001 and 1013, as well as those approved through a Wireless ID Registration and Nomadic Registration, are required to submit an executed performance bond annually via a Tier 1 advice Letter. Pursuant to D.24-11-003, each annual performance bond filing must include supporting documentation that demonstrates that the performance bond remains in full force and continuous for the duration of the telephone corporation's active license or registration with the Commission. Additional supporting documentation with the annual performance bond advice letter is required and can include, but not limited to, a continuation certificate, payment invoice, or other documentation that shows

the performance bond is still in full force and effect to facilitate staff review and confirm the bond is still in effect.

Submit the Annual Performance Bond via the Advice Letter (Tier 1) process and email to [TD\\_PAL@cpuc.ca.gov](mailto:TD_PAL@cpuc.ca.gov). **3) ANNUAL REPORT ON OPERATIONS AND FINANCIALS (DUE MARCH 31, 2026)  
AND ANNUAL AFFILIATE TRANSACTION REPORT (DUE MAY 1, 2026)**

Pursuant to General Order (G.O.) 104-A, D.93-02-019, D.24-11-003, and Operating Authority Decisions and Registration approvals, all Telephone Corporations subject to CPUC jurisdiction are required to file reports on their California operations as specified by the CPUC.

The Annual Report and Affiliate Transaction Reports fall within the CPUC G.O. 66-C and Pub. Util. Code Section 583. These statutes address public inspection of reports filed with the CPUC. Reports are public records and, as such, are open to public inspection unless they are within the exclusions of G.O. 66-C or exempted under the California Public Records Act (Government Code (GC) Section 6250 *et seq.*). Records exempted from public inspection may be made public on a case-specific determination by the CPUC that the public interest in withholding those records clearly outweighs the public interest in disclosure. (See GC Section 6254(a)).

If you **request confidential treatment**, you must submit:

1. One complete copy of the report, and
2. One copy with the claimed confidential information redacted, inserting the term **REDACTED** in the appropriate sections, along with the required confidentiality declaration.

All filings must comply with the confidential document process D.16-08-024.<sup>6</sup>
