Pursuant to General Order 169, Article VI(F), Time Warner Cable Inc. ("TWC") hereby provides notice, as required by Cal. Pub. Util. Code § 5840(m), that on September 30, 2012, it completed an internal reorganization (the "Transaction") involving various TWC subsidiaries and affiliates, including entities that hold Certificates issued by the California Public Utilities Commission: Time Warner Entertainment Company, L.P. ("TWE") [Franchise No. 0020], Time Warner Entertainment-Advance/ Newhouse Partnership ("TWE-A/N") [Franchise No. 0019], Time Warner NY Cable LLC ("TWNY") [Franchise No. 0005] and Time Warner Cable LLC ("TWC LLC") [Franchise No. 0018]. As a result of this internal restructuring, the above-referenced certificates are now held by Time Warner Cable Pacific West LLC ("TWCPW"), an indirect, wholly-owned subsidiary of TWC. For administrative convenience, TWC suggests that the four Certificates now held by TWCPW be consolidated under Franchise No. 0020. *cf.* § 5840(f).<sup>2</sup>

The Transaction will have no impact on existing cable system operations or local staff and management. In particular, there will be no change in our commitment to provide our customers with the best variety and quality in entertainment and information services, all at competitive rates with excellent customer care. Because all affected cable systems will continue to do business as "Time Warner Cable," this Transaction will be entirely seamless from a subscriber standpoint.

Except as set forth below, none of the information submitted by TWE, TWE-A/N, TWNY or TWC LLC with respect to their video service authorization Certificates has changed

Similarly, because consolidation will not result in termination or disruption of service to any customer, and because the surviving Certificate holder, TWCPW, will continue to do business as "Time Warner Cable," written notification to subscribers is unnecessary (and, indeed, would likely result in unnecessary confusion). cf. § 5840(j).

By way of example, and without limitation, the Transaction will not affect (1) any existing video service area footprint, (2) the obligation to comply with all federal and state statutes, rules and regulations, including, but not limited to, those specified in § 5840(e)(1)(B), or (3) the obligation to comply with all lawful city, county or city and county regulations regarding time, place and manner of using the public rights-of-way, including, but not limited to, payment of applicable encroachment, permit and inspection fees.


