(General Order 169(VII)(F)(1))

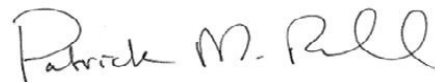
Dear Ms. Pangilinan:

Through a letter served on May 7, 2025, and pursuant to General Order (“G.O.”) 169, Section VII(F)(1) and Public Utilities Code Section 5840(m), Frontier California, Inc. (“Frontier California”) previously notified the California Public Utilities Commission (“Commission”) that Frontier California’s ultimate ownership will be changing from Frontier Communications Parent, Inc. (“Frontier”) to Verizon Communications, Inc. (“Verizon”). Based on the adoption of Item 40 at its January 15, 2026 agenda meeting, the Commission approved the transfer of control as to Frontier California’s telephone corporation operations. *See* D.26-01-023. The parties have now closed the transaction. Therefore, we are providing this further notification to confirm that the change in control has been consummated.

As we previously noted, this parent company ownership change will have no impact on the identity of the video franchise holder under the Digital Infrastructure and Video Competition Act of 2006 (“DIVCA”), which will remain Frontier California. No transfer of the franchise will occur,¹ and Frontier California’s rights and responsibilities under its franchise will remain the same before and after the transaction.

¹ Formal transfer of control submissions are not required under DIVCA where, as here, a reorganization occurs or ultimate ownership changes, but the franchise holder remains the same. *See* Pub. Util. Code § 5840(m), G.O. 169 § VII(F)(1); *see also* August 6, 2015 Letter from Tim McCallion to Michael Morris (addressing notice requirements in connection with Frontier acquisition of Verizon California, Inc., without formal transfer application procedures).
