Pursuant to the seventh application for an amendment of Franchise No. 0034, by Cequel III Communications I, LLC, V2205001, granted on June 24, 2022, Suddenlink Communications has reduced its franchise footprint by eliminating the County of Fresno as an Affected Local Entity, and withdrawing territory in the County of Placer.
