VIOLATIONS

You are hereby cited for having violated section(s) of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.) as described below. These violations occurred on October 29, 2022, in St. Helena California.

- (1) Operated as a charter-party carrier without an operating authority, in violation of Pub. Util. Code section 5371. [1 count]
- (2) Operated a bus without a California Highway Patrol (CHP) inspection in violation of Pub. Util. Code section 5381, G.O. 157-E, Part 4.02, and California Vehicle Code (CVC) section 34501(c) and (e). [1 count]

STATEMENT OF FACTS

The attached investigation summary report documents the violations listed above, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

You are hereby called upon to answer this citation on or before May 1, 2023. By way of such an answer, you may either:

- Pay a fine of \$3,000.00 pursuant to Pub. Util. Code section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Payment Form*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed.) or
- (2) Contest this citation by filing an appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond within the 20 calendar days, you will be in default of the citation and will have forfeited your right to appeal the citation. In addition, your operating authority will be immediately suspended and subsequently revoked, pursuant to Resolution ALJ-187. The Commission may also initiate action through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

NARRATIVE

On March 21, 2023, I was assigned to investigate John Brian Kuhn, Doing Business As (DBA) Vine and Barley (hereinafter Kuhn), after the St. Helena Police Department impounded his bus for operating without valid authority from the Commission.

VIOLATIONS

The investigation for the date of March 18, 2023, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Order (G.O.):

• Operated as a charter-party carrier without an operating authority in violation of Pub. Util. Code section 5371. [1 count]

Pub. Util. Code section 5371 requires all charter-party carriers to obtain a valid operating authority from the commission before engaging in transportation for compensation over public highways in California.

On March 18, 2023, Kuhn's vehicle bearing CA and vehicle identification number was observed by California Public Utilities Commission's (Commission) Consumer Protection and Enforcement Division (CPED) Transportation Enforcement Branch (TEB) Enforcement Analyst Alexander Nera and St. Helena Officer Massella [Attachment 1]. The Commission's Transportation and Licensing Analysis Branch (TLAB) records show that John Brian Kuhn never held authority. Pursuant to Alexander Nera's request, Officer Massella impounded the vehicle [Attachment 2].

• Operated a bus without a California Highway Patrol (CHP) inspection in violation of Pub. Util. Code section 5381, 5374(a)(1)(F), G.O. 157-E, Part 4.02, and California Vehicle Code (CVC) section 34501(c) and (e). [1 count]

Pub. Util. Code section 5374(a)(1)(F) requires the charter-party carrier to maintain its vehicles used in transportation for compensation in a safe operating condition and compliance with the vehicle code and regulations contained in Title 13 of the California Code of Regulations relative to motor vehicle safety. G.O. 157-E, Part 4.02 requires charter-party carrier's vehicles to be inspected by the California Highway Patrol (CHP), and the carrier must maintain proper documentation of inspections. CHP records show vehicle LIC#

CHP on this bus was on November 11, 2014, while owned and operated by Mathew C. Cordero. There is no record that this vehicle having been inspected by CHP under John Brian Kuhn [Attachment 3].

NOTIFICATION:

On 03/18/2023 at approximately 1227 hours, I was on duty, in full police uniform driving a marked patrol vehicle #281. I was parked on the 600 block of Main St when I heard over the radio the California Public Utilities Commission (PUC) Investigator, Alexander Nera requesting SHPD to conduct a traffic enforcement on a black in color Ford E-450 tour bus (24,23) (1993) operating out of compliance.

INVESTIGATION:

As the bus traveled southbound on Main St and passed my location, I safety entered the southbound lane and conducted an enforcement stop of the bus on Main St and Dowdell Ln.

I performed a driver side's approach and contacted a male adult in the driver's seat, who was later identified by his California Driver's Licenses as, John Brian Kuhn. I informed Kuhn the reason for the stop and Kuhn stated he did not need a TCP permit to operate the bus because he does not go to the airport. I informed Kuhn that a PUC Investigator and a Napa County Investigator would talk to him about the TCP license and vehicle code compliance.

Investigator Nera confirmed the vehicle was operating with no TCP permit or certificate issued and stated the vehicle was in violation of CPUC 5411/1037, ref CPUC 5371-1031- *Misdemeanor/Unlawful to operate without proper PUC operating authority*.

Investigator Nera requested I impound the vehicle per CVC 14602.9.

During the contact on Main St, Kuhn asked Investigator Nera if it would be possible to drive the female passengers back to their rental house (1476 Inglewood Ave) because it was their final stop, and he did not want to leave them stranded on the side of the road. Investigator Nera stated that would be fine and we then followed the bus to 1476 Inglewood Ave.

Once I arrived at the final stop, I request a tow for the bus. Pope Valley Towing arrived on scene and took possession of the bus for a 30 day impound, per 14602.9 CVC. See attached "Authorization to Impound" by Public Utilities Commission of the State of California.

ADDITIONAL INFORMATION:

During my contact with Kuhn, I noticed he had approximately ten (10) female passengers in the rear limo style seating of the bus. I could also see red solo cups in the hands of the passengers and a strong odor of alcoholic beverage emitting from the cabin.


