#### VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.) as described below. These violations occurred during the period January 11, 2023, through April 27, 2023.

- Operated as a charter-party carrier after expiration of authority, in violation of Pub. Util. Code section 5379. [2 counts];
- Advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code sections 5414.5 [1 count];
- (3) Operated at an airport without an airport permit and failure to follow airport rules and regulations in violation of Pub. Util. Code section 5371.4(b), 5381 & General Order (G.O.) 157-E Part 3.02 [2 counts].

#### **STATEMENT OF FACTS**

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

#### **RESPONSE**

You are hereby called upon to answer this citation on or before September 18, 2023. By way of such answer, you may either:

- Pay a fine of \$5,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by September 18, 2023, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

#### **INTRODUCTION**

On May 10, 2023, I was assigned to investigate the operations and practices of Abdulhakim Amer Radman Dba Medry Limo Service, TCP 19874 (hereinafter referred as Mr. Radman), due to a San Francisco International Airport (SFO) complaint alleging that Mr. Radman was operating and advertising with an expired authority and operated at SFO without an airport permit and failure to follow airport rules and regulations.

#### VIOLATIONS

I investigated Mr. Radman for the period of January 11, 2023, through April 27, 2023, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.):

### • Mr. Radman operated as a charter-party carrier after expiration of his authority, in violation of Pub. Util. Code section 5379. [2 counts]

Pub. Util. Code 5379 states in part that "After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a charter-party carrier of passengers to conduct any operations as a carrier."

On March 3, 2015, Mr. Radman's authority (P permit) with the Commission expired. This is stated near the top of the P permit and in paragraph (10) [Attachment 1]. Mr. Radman never reactivated his authority after it expired.

On January 11, 2023, Mr. Radman was issued Citation No. **Detected** by the San Francisco Airport Bureau Police Department (SFPD Airport Bureau) where he was found operating with an expired authority at SFO with a vehicle registered to Mr. Radman, license plate number **11**, 2023, Mr. Radman was issued Citation No. **11**, by the SFPD Airport Bureau where he was found operating with an expired authority at SFO with a vehicle registered to Mr. Radman, license plate number [Attachment 2].

On April 27, 2023, I sent a Cease-and-Desist (C&D) Notice via U.S. mail and a subsequent copy to Mr. Radman via email on June 28, 2023. Mr. Radman has never responded to C&D [Attachment 3].

SFPD Airport Bureau citations served to Mr. Radman show he operated two days and conducted two trips while operating with an expired authority [Table 1 and Attachment 2].

### • Mr. Radman advertised as a charter-party carrier without a valid authority in violation of Pub. Util. Code sections 5414.5 [1 count]

Pub. Util. Code 5414.5 states in part that "Every corporation or person who knowingly and willfully issues, publishes, or affixes, or causes or permits the issuance, publishing, or affixing, of any oral or written advertisement, broadcast, or other holding out to the public, or any portion thereof, that the corporation or person is in operation as a charter-party carrier of passengers without having a valid certificate or permit issued under this chapter is guilty of a misdemeanor."

On March 3, 2015, Mr. Radman's authority (P permit) with the Commission expired. This is stated near the top of the permit and in paragraph (10) [Attachment 1]. Mr. Radman never reactivated his authority after it expired. On April 26, 2023, Mr. Radman was found advertising using a business card at SFO by the SFO Ground Transportation Unit (SFO GTU) [Attachment 4].

On April 27, 2023, I sent a Cease-and-Desist (C&D) Notice via U.S. mail and a subsequent copy to Mr. Radman via email on June 28, 2023. Mr. Radman has never responded to C&D [Attachment 3].

Mr. Radman advertised via business card without a valid authority on April 26, 2023 [Table 2 and Attachment 4].

 Table 2: Dates of advertisement without a valid authority:

• Mr. Radman operated at SFO without an airport permit and failed to follow airport rules and regulations, in violation of Pub. Util. Code Section 5371.4(b), 5381 and G.O. 157-E, Part 3.02. [2 counts]

Pub. Util. Code 5371.4(b) states in part, "The governing board of any airport may require a charter-party carrier operating limousines to obtain an airport permit for operating authority at the airport."

Pub. Util. Code 5381 states in part "The commission may supervise and regulate every charter-party carrier of passengers in the State and may do all things, whether specifically designated in this part, or in addition thereto, which are necessary and convenient in the exercise of such power and jurisdiction."

G.O. 157-E, Part 3.02 states," No carrier shall conduct any operations on the property of or into any airport unless such operations are authorized by both this Commission and the airport authority involved. Consistent failure to comply with safety or traffic rules and regulations of an airport authority may result in suspension or revocation of Commission operating authority."

On December 23, 2009, Mr. Radman was sent a letter from SFO that his Airport Operating Permit was been revoked as of January 1, 2010 [Attachment 5].

On January 11, 2023, Mr. Radman was issued Citation No. **Description** by the SFPD Airport Bureau where he was found operating without an airport permit at SFO with a vehicle registered to Mr. Radman, license plate number **Construction**. On April 27, 2023, Mr. Radman was issued Citation No. **Construction** by the SFPD Airport Bureau where he was found operating without an airport permit at SFO with a vehicle registered to Mr. Radman, license plate number [Attachment 2].

On April 27, 2023, I sent a Cease-and-Desist (C&D) Notice via U.S. mail and a subsequent copy to Mr. Radman via email on June 28, 2023. Mr. Radman has never responded to C&D [Attachment 3].

SFPD Airport Bureau citations served to Mr. Radman show he operated for two days and conducted two trips while operating without an airport permit [Table 1 and Attachment 2].

#### **TCP P PERMIT**

The above-named Carrier, having made written application to the Public Utilities Commission of the State of California for a certificate to operate as a CHARTER-PARTY CARRIER OF PASSENGERS, pursuant to Sections 5351 through 5420 of the Public Utilities Code, is granted this certificate authorizing the transportation of passengers by motor vehicle over the public highways of the State of California as a CHARTER-PARTY CARRIER OF PASSENGERS, as defined in said Code, subject to the following conditions:

- 1. This permit is issued pursuant to Public Utilities Code Section 5384(b), and is limited to the use of vehicles under 15-passenger seating capacity.
- 2. No vehicle or vehicles shall be operated by said Carrier unless adequately covered by a public liability and property damage insurance policy or surety bond as required by Public Utilities Code Section 5392.
- Said Carrier shall comply with all Commission orders, decisions, rules, directions, and requirements governing the operations of said Carrier including General Order Series 115 and 157 and shall remit to the Commission the Transportation Reimbursement Fee required by Public Utilities Code Section 403.
- 4. All vehicles operated under this permit shall comply with the requirements of the Motor Carrier Safety Section of the California Highway Patrol. No vehicle shall be operated unless it is named in the Carrier's most recent equipment list on file with this Commission. Written amendments to the equipment list shall be filed within ten days of the date the vehicle is put into or pulled out of service.
- 5. This permit is subject to amendment, modification, suspension or revocation as provided in the Public Utilities Code and in Commission Resolutions PE-498, PE-501, and TL-18336.
- 6. This permit may not be sold, assigned, leased, or otherwise transferred or encumbered without Commission authorization.
- 7. This permit does not authorize the Carrier to conduct operations on the property of or into any airport unless such operation is authorized by the airport authority involved.
- 8. This permit does not authorize round-trip sightseeing tour service.
- 9. The use of top lights and/or taxi meters in all vehicles operated under this permit is prohibited (D. 82-05-069).
- 10. This permit expires 2015-03-03. It may be renewed every three (3) years upon submission and approval of a renewal application. This renewal application should be submitted 90-days prior to the expiration date.

#### NOTICE TO CEASE AND DESIST

Dear Abdulhakim Amer Radmand:

On March 3, 2015, your charter-party operating authority expired.

Public Utilities Code (P.U. Code) Section 5379 states that it is unlawful for a charter-party carrier of passengers to conduct any operations after cancelation or revocation, or during the period of its suspension, or after the expiration of its permit or certificate. P.U. Code Section 5414.5 states that it is unlawful to publish or advertise without holding a valid permit. Advertisements include, but are not limited to, advertising in local directories or yellow pages, business cards, websites, et cetera.

P.U. Code Section 5387 states in part that a charter-party carrier shall have its authority to operate as a charter-party carrier permanently revoked by the California Public Utilities Commission (CPUC) if it operates a bus without having been issued a permit or certificate from the CPUC.

YOU MUST IMMEDIATELY CEASE AND DESIST ANY AND ALL UNLAWFUL OPERATIONS. ANY CARRIER WHICH OPERATES WITHOUT AUTHORITY IS GUILTY OF A MISDEMEANOR WHICH IS PUNISHABLE BY A FINE OF NOT LESS THAN \$1,000 AND NOT MORE THAN \$5,000 FOR EACH VIOLATION OR BY IMPRISONMENT IN THE COUNTY JAIL FOR UP TO THREE MONTHS, OR BOTH (P.U. CODE SECTION 5411). Page 2

This letter places your firm on notice that continued violations of the law without the required authority may result in criminal prosecutions and termination of telephone service. There will be no further warnings.


