VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period from November 12, 2022, through June 2, 2023.

(1) Operated as a charter party carrier after revocation of its operating authority in violation of Pub. Util. Code Section 5379 [1 count]

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before October 10, 2023. By way of such answer, you may either:

- Pay a fine of\$2,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document *"How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by October 10, 2023, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On November 22, 2022, I was assigned to investigate the operations and practices of SFL Enterprises, LLC dba Silver Fox Limousine (Silver Fox), after Program and Project Supervisor Rahmon Momoh observed a Silver Fox limousine (TCP-37912) operating on November 12, 2022, in Temecula after it's TCP permit was revoked on November 7, 2022.

VIOLATION

The investigation for November 12, 2022, through June 2, 2023, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

• Operated as a charter-party carrier after the revocation of its operating authority in violation of Pub. Util. Code Section 5379 [l count].

On May 10, 2022, the California Public Utilities Commission's (CPUC) Transportation Licensing and Analysis Branch (TLAB) sent Silver Fox an email message through the TCP Portal entitled CPUC Notice of Suspended Operating Authority. Attached to this email was a CPUC Order of Suspension letter effective May 10, 2022, due to the LLC being suspended by the California Secretary of State. If the reason for the suspension were not resolved within 180 days, their operating authority would be revoked on November 6, 2022 [Attachment 1].

On November 7, 2022, TLAB sent Silver Fox another email message and an Order of Revocation letter through the TCP Portal advising that its permit was revoked effective November 7, 2022. Unlawful operations are subject to fines and penalties and may include permanent revocation of operating authority or being permanently barred from receiving an operating authority [Attachment 2].

On November 15, 2022, I called Silver Fox's owner, Ryan Roschlau, at -- a n d advised that one of his buses was observed operating after revocation in Temecula on November 12, 2022. Mr. Roschlau confirmed that four of his vehicles (License Plates: operated on November) 12, 2022, and he sent copies of these four waybills to me [Attachment 3]. Mr. Roschlau was aware he was operating after revocation. He said his suspension and subsequent revocation was because the California Secretary of State was behind eight months on their paperwork.

DECLARATION

I have read the foregoing and know the contents thereof. I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief and to those matters, I believe to be true.

CPUC Order of Suspension

This is notice from the California Public Utilities Commission (CPUC) that the operating authority listed on this letter is suspended effective **May 10, 2022**.

Corporation, LLC or LP suspended by CA Secretary of State

Unless the suspension was requested voluntarily, if the reason(s) for the suspension are not resolved within 180 days, on **November 06, 2022**, the operating authority will be revoked. Voluntary suspensions may stay in effect without becoming revoked until the operating authority expires.

After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a Passenger Stage Corporation (PSC) or a Transportation Charter-Party carrier (TCP) of passengers to conduct any operations as a carrier. (California Public Utilities Code §§ 1045, 5379). Unlawful operations are subject to fines and penalties as set forth in the California Public Utilities Code and may include permanent revocation of your operating authority or being permanently barred from receiving an operating authority.

A carrier whose certificate or permit is suspended due to failing to pass a vehicle inspection by the California Highway Patrol (CHP) (California Public Utilities Code § 5378.5, Commission Resolution TL-18336) may obtain a reinspection of its terminal and vehicles by the CHP by submitting a written request for reinstatement to CPUC and paying a reinstatement fee of one thousand dollars (\$1,000). (California Public Utilities Code § 5378.5(b)). Upon receipt of a written recommendation from CHP to suspend a carrier's operating authority, a carrier may request a hearing of the suspension by making a written request to CPUC and the CHP showing cause why the suspension should not be continued.

If your suspension is due to failing to maintain adequate insurance, you must contact your insurance provider to reinstate your policy on-file with the CPUC.
