VIOLATIONS

You are hereby cited with having violated a section of the Public Utilities (Pub. Util.) Code as described below. The violation occurred on April 11, 2025.

- (1) Advertised without authority in violation of Pub. Util. Code Sections 5411 and 5414.5 [3 counts].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before October 7, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$2,000 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by October 7, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On May 14, 2025, I was assigned to investigate the operations and practices of Omar Ricardo Sandoval, doing business as (DBA) Oman Drivers & Shoppers, DBA Omar Sand Private Drivers (Omar Sandoval), initiated by a complaint alleging Omar Sandoval was operating and advertising without authority.

HISTORY OF ENFORCEMENT

Prior Case (PSG-5679): On January 16, 2022, a complaint was received alleging Omar Sandoval was advertising and operating a white Chevy Equinox without authority. On March 3, 2022, the Transportation Enforcement Branch issued a Cease and Desist notice to Omar Sandoval. On January 3, 2023, Omar Sandoval still had not applied for a Transportation Charter Party (TCP) permit; therefore, a second Cease and Desist notice was issued on January 25, 2023, **[Attachment 1]**.

VIOLATIONS

The investigation for May 14, 2025, through July 22, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **Advertised without authority in violation of Pub. Util. Code Sections 5411 and 5414.5 [3 counts].**

On June 4, 2025, I emailed Omar Sandoval, Owner, a Notice to Cease and Desist **[Attachment 2]** since he was advertising without authority on Yelp, Facebook, and Instagram **[Attachment 3]**.

On June 5, 2025, Omar Sandoval emailed me asking why he was receiving the letter. I replied to Omar Sandoval, explaining that he cannot operate or advertise without an active/valid TCP permit, and that we have shown his TCP 41617 as inactive. I also requested proof of auto insurance and copies of his waybills from May 21, 2025, to June 4, 2025. On June 10, 2025, I emailed Omar Sandoval again, asking for the records. He responded on June 12, 2025, stating that he no longer has waybills and is no longer

working. On June 25, 2025, Omar Sandoval emailed me a copy of his Statement of Abandonment of Use of Fictitious Business Name filed on June 9, 2025, along with a Bank of America account closing summary dated June 11, 2025 [**Attachment 4**].

Omar Sandoval is familiar with the Commission's transportation permit process because he initially applied for a TCP permit on May 19, 2022; however, he did not complete the application process and currently holds an inactive TCP permit. A Fictitious Business Name Statement showing a DBA of Oman Drivers & Shoppers with a date of March 30, 2021, was uploaded to his TCP account. Additionally, his Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) program account indicates that Omar Sandoval is enrolled with an enrollment date of May 26, 2022 [**Attachment 5**].

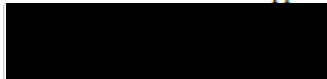

NOTICE TO CEASE AND DESIST

Dear Omar Ricardo Sandoval:

The California Public Utilities Commission (CPUC) became aware that you are operating without valid authority.

Public Utilities Code (P.U. Code) Sections 1031 and 5371 state that it is unlawful for a Passenger Stage Corporation or a Charter-Party Carrier to conduct any operations without valid authority. P.U. Code Sections 1034.5 and 5414.5 state that it is unlawful to publish or advertise without holding a valid operating authority. Advertisements include but are not limited to advertising in local directories or Yellow Pages, business cards, internet websites, and any other form of advertisements.

Your company must immediately cease and desist from all unlawful operations including advertising.

Pub. Util. Code Section 1037 states in part that any PSC carrier which operates without a valid authority is guilty of a misdemeanor and, upon conviction, shall be punished by a fine not to exceed \$1000.

OR

Pub. Util. Code Section 5411 states in part that any TCP carrier which operates without a valid authority is guilty of a misdemeanor and is punishable by a fine not less than \$1,000.

This letter places your company on notice that continued violations of the law without the required operating authority may result in enforcement actions, including criminal prosecutions. There will be no further warnings.
