#### **VIOLATIONS**

You are hereby cited for having violated sections of the Public Utilities (Pub. Util.) Code and a California Public Utilities Commission General Order (G.O.) as described below. These violations occurred from January 1, 2025, through October 28, 2025.

- (1) Engaged employee-drivers without evidence of Workers' Compensation (WKCP) insurance in effect and on file with the Commission in violation of Pub. Util. Code Section 5378.1 **[3 counts]**;
- (2) Failed to maintain and enroll drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice Program (EPN) in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E, Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 **[2 counts]**;
- (3) Failed to enroll drivers in a mandatory Controlled Substance and Alcohol Testing (CSAT) Certification Program for Pre-Employment Testing in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10 **[3 counts]**;
- (4) Failed to maintain a current equipment list with the Commission in violation of Pub. Util. Code Sections 5381 and 5411 and G.O. 157-E, Part 4.01 **[1 count]**;
- (5) Failed to display the Charter-Party Carrier (TCP) number and authorized suffix of its permit on a vehicle in violation of Pub. Util. Code Sections 5385 and 5411.3 and G.O. 157-E, Part 4.04 **[1 count]**; and

(6) Failed to state the TCP number and authorized suffix of its permit in advertisements to the public for services in violation of Pub. Util. Code Section 5386 and G.O. 157-E, Part 3.07 **[2 counts]**.

## **STATEMENT OF FACTS**

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

## **RESPONSE**

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before December 15, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$7,000 pursuant to Pub. Util. P.U. Code Section 5378. Submit your check or money order payable to CPUC using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal*."

If you fail to respond by December 15, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

## INTRODUCTION

On July 31, 2025, I was assigned to investigate the operations and practices of Makalani Hodari and Baker Lynette doing business as LA Hood Life & Hip Hop Tours (hereinafter referred to as LA Hood) because the Transportation Enforcement Branch (TEB) received a complaint from the Los Angeles Police Department (LAPD). The complaint alleged that LA Hood owner Hodari Makalani Sababu (Mr. Sababu) operated a 1967 Chevrolet (license plate [REDACTED]) in Los Angeles on July 18, 2025. However, the 1967 Chevrolet (license plate [REDACTED]) was not on its equipment list and did not display its Charter-Party Carrier (TCP) number (28884-S) [Attachment 1].

## VIOLATIONS

I investigated LA Hood from January 1, 2025, to October 28, 2025, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and a California Public Utilities Commission General Order (G.O.):

- **Engaged employee-drivers without evidence of Workers' Compensation (WKCP) insurance in effect and on file with the Commission in violation of Pub. Util. Code Section 5378.1. [3 counts]**

On August 21, 2025, I emailed a data request for waybills from July 1, 2025 to July 31, 2025, to Mr. Sababu at [REDACTED]. On September 15, 2025, I received waybills from Mr. Sababu's proxy, [REDACTED], at [REDACTED] [Attachment 2].

These waybills showed that employee-drivers [REDACTED] [REDACTED] drove for LA Hood during the period between July 1, 2025, and July 31, 2025 [Table 1]. However, records of the Transportation Licensing and Analysis Branch (TLAB) show that LA Hood did not hold a WKCP Insurance Policy during the period from July 1, 2025, to September 5, 2025.

- **Failed to maintain and enroll drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E, Part 5.02, and the California Vehicle Code (CVC) Section**

**1808.1. [2 counts]**

On August 8, 2025, I looked up LA Hood's DMV EPN requestor code, [REDACTED] and confirmed that LA Hood had not enrolled [REDACTED] in its DMV EPN Program **[Attachment 3]**. Its waybills, however, show that both drove for LA Hood during the period from July 1, 2025, to July 31, 2025 **[Table 1]**.

- **Failed to enroll drivers in a mandatory Controlled Substance and Alcohol Testing (CSAT) Certification Program for Pre-Employment Testing in violation of Pub. Util. Code Section 5374(a)(1)(I) and G.O. 157-E, Part 10. [3 counts]**

On August 29, 2025, I emailed a data request to New Era Drug Testing Program Consultant [REDACTED] at [REDACTED], requesting the list of drivers enrolled in LA Hood's CSAT Program. On September 4, 2025, [REDACTED] responded that only Mr. Sababu had been enrolled in LA Hood's CSAT Program since January 1, 2025 **[Attachment 4]**. However, waybills show that [REDACTED] [REDACTED] drove for LA Hood during the period between July 1, 2025, and July 31, 2025 **[Table 1]**.

- **Failed to maintain a current equipment list with the Commission in violation of Pub. Util. Code Sections 5381 and 5411 and G.O. 157-E, Part 4.01. [1 count]**

LA Hood's waybills show that [REDACTED] drove a 2009 Ford (license plate 31393J3) for LA Hood between July 1, 2025, and July 31, 2025 **[Table 1]**. However, TLAB records show that the 2009 Ford (license plate [REDACTED]) had not been on its equipment list until September 9, 2025.

- **Failed to display the Charter-Party Carrier (TCP) number and authorized suffix of its permit on a vehicle in violation of Pub. Util. Code Sections 5385 and 5411.3 and G.O. 157-E, Part 4.04. [1 count]**

On September 18, 2025, during a joint field operation with the Hollywood Division of the LAPD, I observed that the 2009 Ford (license plate [REDACTED]) did not display its TCP number correctly **[Attachment 5]**.

- **Failed to state the TCP number and suffix of its permit in advertisements to the public for services in violation of Pub. Util. Code Section 5386 and G.O. 157-E, Part 3.07. [2 counts]**

On September 12, 2025, I observed that LA Hood advertised its services on Facebook and Instagram without stating its TCP number. On October 21, 2025, I emailed Mr. Sababu, requesting that LA Hood add its TCP number to its commercial Facebook and Instagram

accounts by October 24, 2025. To date, LA Hood has failed to add its TCP number to either platform **[Attachment 6]**.

I have read the foregoing and know the contents thereof, and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and, to those matters, I believe to be true.

My Partners, Officer Madjd #42075, Officer Peccoralo #43580 and I, Officer Heale #40774, have attended multiple training classes provided by the California Public Utilities Commission (CPUC) on their rules and regulations for commercial vehicles. We have also received additional training provided by officers that specialize in commercial vehicle enforcement on requirements for commercial vehicles to operate. We have also received multiple roll call training regarding rules and regulations for commercial vehicles.

Source of Activity:

On 07/18/2025 at approx. 1350 hours my partners (Ofcr Madjd #42075 and Ofcr Peccoralo #43580) and I (Ofcr Heale #40774) were assigned to Hollywood Division. We were in full police uniform and driving a marked black and white police vehicle. We were travelling W/B on Hollywood Blvd from Ivar Ave when we observed a Black Chevrolet Impala low rider (Lic# [REDACTED] parking in front of 6326 Hollywood Blvd with no TCP number displayed on the vehicle (General Order 157-D 4.04 TCP/CPUC). [REDACTED]

Investigations:

My partners and I observed a Black 1967 Chevrolet Impala [REDACTED] marked W/B in front of 6326 Hollywood Blvd with not TCP number on the vehicle. We conducted a traffic stop on the 1967 Chevrolet Impala [REDACTED] the driver (Hodari Sababu) stated he was giving them a free tour because they bought a bus tour. At the time of the stop, we observed several people sitting in the front passenger seat and the back seat of the Chevrolet Impala. Witness #1 ([REDACTED] stated they paid \$200.00 to go on a bus tour with LA Hood Life Tours and a low rider tour (Chevrolet Impala). [REDACTED] stated the low rider tours is advertised on the LA Hood Life Tours website (lahoodlifetours.com). Witness 1 was seated in the back passenger seat. Witness 2 [REDACTED] was seated in the back driver side seat and Witness 3 [REDACTED] was seat in the front passenger seat.
