The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.


RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before December 16, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$ 2,000 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by December 16, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

## INTRODUCTION

On July 25, 2025, I was assigned to investigate the operations and practices of Epic Transportation Services, Inc. (hereinafter referred to as Epic) because of a referral from the California Public Utilities Commission's (CPUC) Fiscal Office. Epic failed to respond to multiple requests from the Fiscal Office to provide its tax documents for the years 2022, 2023, and 2024 as part of a CPUC audit [Attachment 1].

## VIOLATIONS

I investigated Epic for the period of July 25, 2025, to October 31, 2025. The investigation disclosed the following violation of the Public Utilities (Pub. Util) Code and the California Public Utilities Commission (Commission) General Order (G.O.) provisions.

- **Failure to produce records, in violation of Pub. Util. Code Sections 5381 and 5389 and G.O. 157-E, Part 6.02. [1 count].**

On July 29, 2025, I called [REDACTED], Curtis Miller, Director of Epic. I verified his email address, phone number, and physical address with him [Attachment 2]. I talked to Mr. Miller, who stated he had not received the fiscal audit notices. I forwarded all three notices via Microsoft Outlook, [REDACTED] [Attachment 3]. Per Microsoft Outlook, the email was delivered to Mr. Miller [Attachment 4].

On August 5, 2025, I called Curtis Miller at [REDACTED] and left a voice message regarding the audit notice. He returned my call from [REDACTED]. Mr. Miller confirmed receipt of my data request email sent on July 29, 2025 [Attachment 5].

On August 11, 2025, I emailed a data request letter - 1 to Curtis Miller at [REDACTED] via Microsoft Outlook [Attachment 6]. As per Microsoft Outlook, the email was delivered to Mr. Miller [Attachment 7]. Subsequently, Enforcement Analyst Shawndra Miles mailed the same letter via the United States Postal Service (USPS) certified mail to [REDACTED].

On August 15, 2025, USPS tracking records indicate that the mail tracking number [REDACTED] was delivered at [REDACTED] [Attachment 8].

On August 19, 2025, and August 25, 2025, I called [REDACTED] and [REDACTED] to follow up on the emails that I sent and left a voice message [Attachment 9].

On September 5, 2025, I emailed a final letter for data submission to Curtis Miller at [REDACTED] via Microsoft Outlook [Attachment 10]. Per Microsoft Outlook, the email was delivered to Mr. Miller [Attachment 11].

On September 12, 2025, I made a follow-up phone call to [REDACTED] regarding the pending data request for the PUCTRA revenue reports for the years 2022, 2023, and 2024. During the phone call, Mr. Miller confirmed receipt of my data request email sent on September 5, 2025 [Attachment 12].

On October 31, 2025, I sent a follow-up email to Mr. Miller about the PUCTRA revenue report that was requested by the CPUC Fiscal Office [Attachment 13].

As of November 18, 2025, Curtis Miller from Epic Transportation has not provided the requested information. Epic Transportation has failed to produce the requested records despite multiple attempts to work with the carrier.
