TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before October 10, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$1,500 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by October 10, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On September 15, 2025, I was assigned to investigate the operations and practices of HaiJun Li because he was observed operating without authority during the Levi's Stadium Joint Operation with the California Highway Patrol. Subsequently, HaiJun Li's minivan with license plate was impounded by CHP [Attachment 1].

VIOLATIONS

I investigated HaiJun Li on September 13, 2025, and found a violation of the following provisions of the Public Utilities (Pub. Util.) Code and California Vehicle Code (CVC).

• Operated as a Charter-Party Carrier (TCP) after revocation of authority, in violation of Pub. Util. Code Section 5371 and CVC 14602.9. [1 count]

During Levi's Stadium Joint Operation, CHP Officer observed HaiJun Li approach six (6) passengers in the Transportation Network Company (TNC) Lot 7 and solicit passengers. Office Tam observed that one of the passengers paid \$60 in cash to HaiJun Li. Officer Tam approached HaiJun Li and interviewed the passengers. It was confirmed that HaiJun Li was paid \$60 in cash to take the six (6) passengers from Levi's Stadium to Fremont, CA. I confirmed with the Transportation Licensing and Analysis Branch (TLAB) database that HaiJun Li had never held an operating authority. I served the Observation Report to HaiJun Li, and he acknowledged and signed the Report [Attachment 2]. Subsequently, I submitted the Request to Impound Form (CHP 180) to CHP Officer to impound the vehicle.[Attachment 3].
