VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities Code (P.U. Code) and California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred from October 20, 2024, through May 19, 2025.

- (1) Bongel Limousine LLC operated as a charter-party carrier after suspension of its authority in violation of Pub. Util. Code Sections 5379 and 5411 **[4 counts]**
- (2) Bongel Limousine LLC failed to enroll four (4) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 **[4 counts]**
- (3) Bongel Limousine LLC failed to include pertinent information on a waybill in violation of Pub. Util. Code Section 5381 and General Order 157-E, Part 3.01 **[1 count]**

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before June 18, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$6,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by June 18, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On October 30, 2024, I was assigned to investigate the operations and practices of Bongel Limousine LLC dba BNG Transportation Group (Bongel Limousine). This assignment came after Transportation Enforcement Branch (TEB) staff observed Bongel Limousine operating after its authority was suspended at the Levi's Stadium Joint Field Operation with the Santa Clara Police Department on October 20, 2024 [**Attachment 1**].

VIOLATIONS

The investigation for October 20, 2024, through May 19, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **Operated as a charter-party carrier after suspension of its authority in violation of Pub. Util. Code Sections 5379 and 5411 [4 counts].**

On October 15, 2024, the Transportation Licensing and Analysis Branch (TLAB) sent an Order of Suspension to Bongel Limousine for failure to pay or report quarterly user fees (Public Utilities Commission Transportation Reimbursement- PUCTRA fees). [**Attachment 2**].

On October 20, 2024, Transportation Enforcement Branch (TEB) staff observed a black Chevrolet Suburban van (License Plate: ██████████) operating after its authority was suspended. At the time of this observation, TEB staff issued an Inspection Observation Report and a Notice of Cease and Desist [**Attachment 3**].

Based on the waybills provided by Bongel Limo, the carrier operated during the suspension period on October 16, 17, 18, and 20, 2024 [**Table 1 and Attachment 4**].

On October 21, 2024, TLAB sent an Order of Reinstatement to Bongel Limousine [**Attachment 5**].

- Failed to enroll four (4) drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) Program in violation of Pub. Util. Code Section 5374(a)(1)(D), G.O. 157-E Part 5.02, and the California Vehicle Code (CVC) Section 1808.1 [4 counts]**

A search of the DMV EPN System on May 9, 2024, showed that Mohamed Aym Khalil, CEO, CDL: [REDACTED] [Attachment 5], was the only driver enrolled under EPN requestor code [REDACTED].

On February 26, 2024, I received information from Uber showing that 4 drivers operated under Bongel Limousine's account within the Uber Platforms [Table 2 and Attachment 7].



This is notice from the California Public Utilities Commission (CPUC) that the **TCP CLASS B CERTIFICATE** listed on this letter is suspended.

The table below lists the reason(s) for suspension; the effective date of the suspension(s); and the date the permit/certificate will be revoked if the reason(s) for suspension are not resolved.
