STATEMENT OF FACTS

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before July 10, 2025. By way of such answer, you may either:

- (1) Pay a fine of \$1,500 pursuant to P.U. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by July 10, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On March 26, 2025, I was assigned to investigate the operations and practices of SoCal Travel Tours (hereinafter referred to as SoCal Travel) following a consumer complaint received by the Transportation Enforcement Branch (TEB) alleging that the carrier was operating and advertising without a TCP permit [**Attachment 1**].

VIOLATION

The investigation from March 26, 2025, to April 23, 2025, revealed violations of the following provisions of the Public Utilities (Pub. Util.) Code and a Commission General Order (GO):

- **SoCal Travel Tours was found advertising illegally in violation of Pub. Util. Code Section 5414.5 [1 count].**

On March 27, 2025, I called SoCal Travel at [REDACTED] and left a voicemail message. On April 15th, I received a call from Jordan Villa at [REDACTED], the carrier's representative, due to the carrier's limited ability to speak or understand English. I informed Mr. Villa of the TCP permit requirements and the license section's email address for any other permit-specific questions.

Following the phone conversation, I sent Mr. Villa an email at [REDACTED], serving the carrier a Notice to Cease and Desist (C&D) letter. Additionally, I provided him with the necessary information regarding applying for a TCP permit, and also gave him a deadline of May 9th for SoCal Travel to remove all online advertisements [**Attachment 2**]. In the same email, I also provided Mr. Villa with the email address of our Licensing Branch (licensing@cpuc.ca.gov), in case he or the carrier had any follow-up questions regarding the permit process.

On April 17th, I received an email from Yukako Ogata, the Chief Coordinator, stating she had received my C&D and understands the expectations to stop providing transportation services immediately and to remove all advertisements by May 9th [**Attachment 3**]. I responded to Ms. Ogata and provided our Licensing Branch's email address in case she had any questions related to

the permit process [**Attachment 3**]. My investigation included searches on Google, Yelp, and Nextdoor to identify additional platforms where the carrier may be advertising. However, the only observed advertising presence was on the carrier's website (social-travel.com/socialtraveltour.com). I observed the carrier advertising from April 15th through April 23rd [**Attachment 4**], but the carrier was cooperative with the instructions to remove its website by May 9th [**Attachment 5**]. The carrier initiated the application process in April 2025; however, the carrier's TCP number, 47879, remains inactive as of June 17, 2025 [**Attachment 6**].

Thank you for giving me a call regarding SoCal Travel Tours, as the owners are not able to speak or understand English very well. As discussed on the phone, this carrier must have a license to advertise and provide transportation services for hire.

I am attaching a cease-and-desist, stating SoCal Travel Tours must immediately cease any advertisements and transportation services until receiving a permit from the California Public Utilities Commission (CPUC). Please have the owners remove the website by May 9, 2025, and immediately halt any transportation services. Failure to do so may result in a citation.

Additionally, from our conversation, I also understood that you were looking for information to provide to the owners so they can begin the process of applying for a permit.
