VIOLATIONS

You are hereby cited with having violated a section of the Public Utilities (Pub. Util.) Code. The violation occurred on June 18, 2025.

- (1) Operated as a charter-party carrier without an operating authority in violation of Pub. Util. Code Section 5371. [1 count]

STATEMENT OF FACTS

The above violation is documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before July 10, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$ 1,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission (CPUC) using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by July 10, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

NARRATIVE

On June 19, 2025, I was assigned to investigate Singh Amandeep (hereinafter referred to as Singh) after the van he was operating was impounded by the California Highway Patrol (CHP) for operating without authority from the California Public Utilities Commission (CPUC) on June 18, 2025.

VIOLATIONS

The investigation for the date of June 18, 2025, disclosed violations of the following provisions of the Public Utilities (Pub. Util.) Code and Commission General Order (G.O.):

- **Operated as a charter-party carrier without an operating authority in violation of Pub. Util. Code Section 5371. [1 count]**


On June 18, 2025, I, Enforcement Analyst, Alexander Nera of the CPUC's Consumer Protection and Enforcement Division (CPED), Transportation Enforcement Branch (TEB), along with California Highway Patrol (CHP) Officer Tam, observed a vehicle operated by Singh, California license plate [REDACTED], providing transportation for compensation without a valid authority in the international arrival zone at San Francisco International Airport (SFO) [Attachment 1]. Passenger Rhaniel Pamintuah stated that he paid Singh \$300 to transport him and his family to SFO [Attachment 2].

I conducted a records check with the Commission's Transportation and Licensing Analysis Branch (TLAB), which confirmed that Singh has never held an operating authority with the CPUC. Enforcement Analyst Sheela Dawadi issued Singh a Cease-and-Desist Notice (C&D) for operating without CPUC authority [Attachment 3]. Based on this information, I obtained approval from TEB Supervisor Eric Hooks to request that Officer Tam impound the vehicle in accordance with enforcement protocol [Attachment 4].



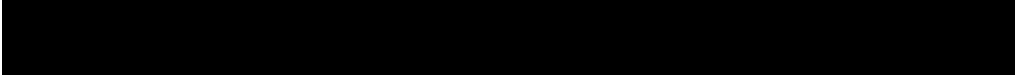
