VIOLATIONS

You are hereby cited as having violated a section of the Public Utilities (Pub. Util.) Code and California Vehicle Code (CVC) as described below. The violation occurred during the period of June 18, 2025.

- (1) Operated as a Charter-Party Carrier after revocation of its authority, in violation of Pub. Util. Code Section 5379 and CVC 14602.9 [**1 count**].

STATEMENT OF FACTS

The above violation is documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before July 10, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$1,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the CPUC staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal*."

If you fail to respond by July 10, 2025, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The California Public Utilities Commission (CPUC) may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and CPUC orders.

INTRODUCTION

On June 20, 2025, I was assigned to investigate the operations and practices of X Y Shuttle Travel Service Inc. (hereinafter referred to as X Y Shuttle), charter-party carrier (TCP) 21583-P, after X Y Shuttle was observed operating after revocation of its authority during at the San Francisco International Airport (SFO) on June 18, 2025. X Y Shuttle's silver Toyota Sienna van (License Plate [REDACTED], VIN [REDACTED]) was subsequently impounded by California Highway Patrol (CHP) for operating after revocation of its authority [Attachment 1].

VIOLATIONS

I investigated X Y Shuttle for the period of June 18, 2025, and found a violation of the following provisions of the Public Utilities (Pub. Util.) Code and California Vehicle Code (CVC).

- **Operated as a Charter-Party Carrier (TCP) after revocation of authority, in violation of Pub. Util. Code Section 5379 and CVC 14602.9. [1 count]**

Pub. Util. Code 5379 states in part that "After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a charter-party carrier of passengers to conduct any operations as a carrier."

CVC 14602.9 states in part that "A peace officer may impound a bus or limousine of a charter-party carrier for 30 days if the officer determines that any of the following violations occurred while the driver was operating the bus or limousine of the charter-party carrier: the driver was operating the bus or limousine of a charter-party carrier when the charter-party carrier did not have a permit or certificate issued by the Public Utilities Commission, pursuant to Section 5375 of the Public Utilities Code."

A review of the CPUC's Transportation Licensing and Analysis Branch records shows that X Y Shuttle entered voluntary revocation of its authority on July 2, 2007 [Attachment 2].

During the SFO joint safety operation, a vehicle bearing California license plate [REDACTED] was observed parked in the SFO International Arrivals Terminal with two passengers inside, soliciting TCP business [Attachment 3]. During my safety compliance check on X Y Shuttle, I sought language translation assistance from Acting Program and Project Supervisor, Shirley Lei, as both the passengers and driver spoke Chinese. Shirley Lei obtained both a verbal and written confirmation from the passenger, [REDACTED], that a payment of \$80 U.S. Dollars was going to be paid to driver, Jin Sheng Zheng, for transportation from SFO to Fremont [Attachment 4]. I issued X Y Shuttle a Notice to Cease and Desist and Observation Report [Attachment 5]. I submitted the Request to Impound Form to CHP, [REDACTED], who impounded the vehicle on June 18, 2025 [see Attachment 1].

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.




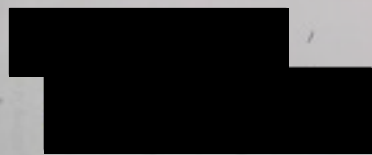
