#### **VIOLATIONS**

You are hereby cited as having violated sections of the Public Utilities (Pub. Util.) Code and General Order (G.O.) as described below. These violations occurred during the period of February 25, 2025, to June 10, 2025.

- (1) Operated as a Charter-Party Carrier after revocation of authority in violation of Pub. Util. Code Section 5379 [2 counts]; and
- (2) Operated at an airport without an airport permit and failed to follow airport rules and regulations in violation of Pub. Util. Code Section 5371.4(b) and G.O. 157-E, Part 3.02 [3 counts].

## **STATEMENT OF FACTS**

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

### **RESPONSE**

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before September 29, 2025. By way of such an answer, you may either:

- (1) Pay a fine of \$5,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the CPUC staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See the attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by September 29, 2025, you will be in default and will have forfeited your right to appeal the Citation. The CPUC may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and CPUC orders.

#### INTRODUCTION

On March 20, 2025, I was assigned to investigate the operations and practices of Osama R. Rashed Dba Mayar Limousine Service (hereinafter referred to as Osama R. Rashed), Charter-Party Carrier (TCP) 21447-P, because of a complaint from the San Francisco International Airport (SFO) Ground Transportation Unit (GTU) alleging that Osama R. Rashed was operating after revocation of his CPUC authority and operated at an airport without an airport permit, and failed to follow airport rules and regulations.

#### **VIOLATIONS**

I investigated Osama R. Rashed for the period of February 25, 2025, to June 10, 2025, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and CPUC General Orders (G.O.):

 Operated as a Charter-Party Carrier after revocation of authority in violation of Pub. Util. Code Section 5379. [2 counts]

On May 2, 2018, CPUC's Transportation Licensing and Analysis Branch sent the Order of Revocation of Operating Authority to Osama R. Rashed via the TCP Portal [Attachment 1]. The Order notified Osama R. Rashed that his TCP operating authority was revoked effective May 2, 2018, for failure to pay annual fees for 2017, and any unlawful operations are subject to fines and penalties as outlined in the Pub. Util. Code.

On February 25, 2025, SFO GTU Investigator Jack Chen issued Osama R. Rashed Administrative Citation No. 48496 and Notice to Cease-and-Desist (C&D) No. 24-10854 [Attachment 2] for operating a chauffeur business without authorization, operating after revocation of his CPUC authority, no TCP displayed, and no SFO airport permit. On April 9, 2025, I sent a C&D via USPS Certified Mail with tracking number 7022 2410 0003 2544 8318 and via email <a href="mailto:mayarlimo@yahoo.com">mayarlimo@yahoo.com</a> to Osama R. Rashed [Attachment 3]. On June 10, 2025, I spoke with Osama R. Rashed and confirmed that he had received my C&D via email. I explained to him that I had received a report from SFO GTU stating that he was operating as a TCP after revocation of his CPUC authority. Osama R. Rashed stated that he picks up his wife and family members at SFO because his wife works there. He also mentioned that he works for Uber. I

directed him to stop operating as a TCP at SFO. On the same day, I sent an email to SFO GTU Investigator Jack Chen regarding Osama R. Rashed's statements. SFO GTU Investigator Jack Chen responded, confirming that SFO GTU is aware that Osama R. Rashed's wife works in the at SFO with a usual drop-off and pick-up time. He also provided pictures of Osama R. Rashed soliciting rides and picking up passengers at the SFO terminals on February 25, 2025, and June 7, 2025 [Attachment 4].

On June 11, 2025, I sent a Data Request to Uber Technologies, Inc. due to Osama R. Rashed's claim that he works for Uber [Attachment 5]. On June 23, 2025, Uber Technologies, Inc. replied to my Data Request, stating that the vehicle with license plate No. was not active on the Uber platform during the review period specified in the Data Request [Attachment 6]. My investigation disclosed that Osama R. Rashed operated for two (2) days and conducted two (2) trips after the revocation of his TCP authority, as indicated in Table 1.

Operated at an airport without an airport permit and failed to follow airport rules and regulations in violation of Pub. Util. Code Section 5371.4(b), and G.O. 157-E, Part 3.02. [3 counts]

On February 25, 2025, SFO GTU Investigator Jack Chen issued Osama R. Rashed Administrative Citation No. 48496 and C&D No. 24-10854 (see **Attachment 2**) for operating a chauffeur business without authorization, operating after revocation of his CPUC authority, no TCP displayed, and no SFO airport permit. On June 10, 2025, I emailed SFO GTU Investigator Jack Chen regarding Osama R. Rashed's statements and requested photo evidence and any trips Osama R. Rashed had conducted during the review period. SFO GTU Investigator Jack Chen provided statements with photo evidence of Osama R. Rashed soliciting rides from individuals at the SFO terminals on February 25, 2025, and June 7, 2025. On May 27, 2025, Osama R. Rashed was found pulling into the limousine curb designated for commercial limousines only and left once he saw SFO GTU Investigator Jack Chen approaching his vehicle (see **Attachment 4**). My investigation disclosed that Osama R. Rashed failed to follow airport rules and regulations on

three (3) separate days, as indicated in **Table 2**.

Failure to Pay Annual Fees for 2017

Any carrier which operates with revoked operating authority(s) is guilty of a misdemeanor which is punishable by a fine of not less than \$1,000 or imprisonment of up to three months, or both. Additionally, Public Utilities Code Section 5387(c)(1) provides that a carrier which operates a bus without holding operating authority from the Commission shall be permanently barred from receiving a permit or certificate from the Commission.

Hello,

Attached is Citation#48496. Today, your vehicle with LIC# was seen operating at SFO without SFO Airport authority.

Please Cease and Desist any commercial transportation that requires CPUC and Airport Authority at SFO until you have obtained the proper authority to do so.

Continuing to operate may result in an administrative fine for each trip conducted, recollection of trip fees and further investigation by CPUC for violating the Public Utilities Codes and General Order 157-E.

**CPUC General Order 157-E § 3.02:** No carrier shall conduct any operations on the property of or into any airport unless such operations are authorized by both this Commission and the airport authority involved. Consistent failure to comply with safety or traffic rules and regulations of an airport authority may result in suspension or revocation of Commission operating authority.

**Public Utilities Code Section 5379:** After the cancellation or revocation of a permit or certificate, or during the period of its suspension, or after the expiration of its permit or certificate, it is unlawful for a charter-party carrier of passengers to conduct any operations as a carrier. The commission may either grant or deny an application for a new permit or certificate whenever it appears that a prior permit or certificate of the applicant has been canceled or revoked pursuant to Section 5378 or whenever it appears, after hearing, that as a prior permit or certificate holder, the applicant engaged in any of the unlawful activities set forth in Section 5378 for which his or her permit or certificate might have been canceled or revoked.

**Public Utilities Code Section 5411:** Every charter-party carrier of passengers and every officer, director, agent, or employee of any charter-party carrier of passengers who violates or who fails to comply with, or who procures, aids, or abets any violation by any charter-party carrier of passengers of any provision of this chapter, or who fails to obey, observe, or comply with any order, decision, rule, regulation, direction, demand, or requirement of the commission, or of any operating permit or certificate issued to any charter-party carrier of passengers, or who procures, aids, or abets any charter-party carrier of passengers in its failure to obey, observe, or comply with any such order, decision, rule, regulation, direction, demand, requirement, or operating permit or certificate, is guilty of a misdemeanor and is

punishable by a fine of not less than one thousand dollars (\$1,000) and not more than five thousand dollars (\$5,000) or by imprisonment in a county jail for not more than three months, or by both that fine and imprisonment.

#### NOTICE TO CEASE AND DESIST

Dear Osama R. Rashed:

On May 2, 2018, your Charter-Party Carrier (TCP) authority was revoked for failure to pay annual fees for 2017.

Public Utilities (Pub. Util.) Code Section 5379 states in part that it is unlawful for a TCP to conduct any operations after cancellation or revocation, or during the period of its suspension, or after the expiration of its authority. Pub. Util. Code Section 5414.5 states that it is unlawful to publish or advertise without a valid authority. Advertisements include, but are not limited to, advertising in local directories or Yellow Pages, business cards, websites, etc.

Your company must immediately cease and desist from all unlawful operations, including advertising. Pub. Util. Code Section 5411 states in part that any carrier which operates without a valid authority is guilty of a misdemeanor and is punishable by a fine of not less than \$1,000.

On February 25, 2025, your company was found operating without a valid authority at the San Francisco International Airport (SFO) and was issued Citation Number 48496 by the SFO's Ground Transportation Unit (GTU).

This letter places your company on notice that continued violations of the law without the required authority may result in enforcement actions, including criminal prosecutions. There will be no further warnings.


We are aware that Mr. Rashed's wife works at SFO. Based off our observations, she works inside of and is usually dropped off in the mornings hours, then picked up in the afternoon hours.

As for the incident on 2/25/2025, here's the description from my daily report on Mr. Rashed:

"At 0944, encountered known solicitor Osama Rashed operating a black on the on-ramp heading into the terminals. I followed him as he took the McDonnell Rd exit, and I lost sight of him as he sped into Courtyard A. At 0951 hours, saw him on the terminal loop and when he sped into domestic arrivals via the inner curb, I took the outer curb in an attempt to follow him, but he was driving too fast. I eventually found him at T3 loading a female passenger's luggage into his trunk. I parked at the T3 taxi lane, hopped over to grab the attention of the female passenger, and informed her that Osama was not a taxi. She explained that a university had hired a chauffeur to pick her up, and it was most likely Osama since he knew her name beforehand. I asked if she could provide any emails or messages just to make sure Osama was indeed her ride, but she wasn't able to provide any information and eventually entered his vehicle. Before leaving, I reiterated that Osama is an illegal operator without proper insurance and snapped a photo of Osama as he drove off angrily. "

The mentioned admin citation and notice to cease & desist was sent to him via email (please see attached email).

I've also attached a spreadsheet listing all the hits from our LPRs (license plate reader) between 2/26/25- today (6/10/25), and it has registered 569 reads during this period. Since Mr. Rashed is a known solicitor, he typically solicits at both the International and Domestic Arrivals level. Please keep in mind that when he does drop off or pick up his wife, it should fall under "domestic arrivals" around hours. He should not be entering International Arrivals for any legitimate reasons besides "picking up family members." I looked at his most recent LPR hit and cross referenced it with our surveillance camera and found him soliciting:

Mr. Rashed enters IT Arrivals at 1853 hours and pulls into the curb.



After parking, Mr. Rashed walked straight up to 2 passengers and spoke with them (attempting to solicit). The two passengers do not take his offer and he walks into the terminal to solicit further.



About 10 minutes later Mr. Rashed leads two female passengers to his vehicle. The interaction does not look very family-like.



Mr. Rashed loading their luggage into his vehicle.



The 2 passengers both get in the back seat (also very not family-like).

Additionally, here's another example of Mr. Rashed coming to the airport without the intention of picking up family members. On 5/27/2025, I encountered him as he was trying to pull into the limo stand (commercial limousine ONLY zone) at the International Terminal. He saw me and left, and did not return during my duration there. That would be a very unusual spot to pick up family members, especially for him to not return:

Good afternoon, Jack,

I'm not sure if you remember me but my name is MaiKa Renda, I am an Enforcement Analyst with the Airport Enforcement Unit. I was assigned to investigate a complaint that you had sent over to the Transportation Safety Complaint Team.

The complaint is for Osama Rashed dba Mayar Limousine Service. I spoke with Mr. Rashed earlier, and he had claimed that he goes to SFO to pick up his wife/family member. He also claimed that he never received your Admin. Citation nor Cease-and-Desist Notice for February 25, 2025. 
