#### **VIOLATIONS**

You are hereby cited as having violated sections of the Public Utilities (Pub. Util.) Code and the California Public Utilities Commission (CPUC) General Order (G.O.) as described below. These violations occurred during the period of November 7, 2025, and November 14, 2025.

- (1) Operated at an airport without an airport permit and failed to follow airport rules and regulations in violation of Pub. Util. Code Section 5381 and G.O. 157-E, Part 3.02. [**2 counts**]
  
- (2) Engaged one employee-driver without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the CPUC, in violation of Pub. Util. Code Section 5378.1. [**2 counts**]

STATEMENT OF FACTS

The above violation is documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before March 25, 2026. By way of such an answer, you may either:

- (1) Pay a fine of \$4,000 pursuant to Pub. Util. Code Section 5378. Submit your check or money order payable to CPUC using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund, and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this Citation by filing an Appeal. See attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by March 25, 2026, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

## INTRODUCTION

On November 14, 2025, I was assigned to investigate the operations and practices of Exquisite Transportation Services LLC, doing business as (dba) ETS United (hereinafter referred to as Exquisite Transportation) because of a complaint alleging that Exquisite Transportation operated at San Francisco International Airport (SFO) without an airport permit.

## VIOLATIONS

I investigated Exquisite Transportation for the period November 7 through November 14, 2025, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and CPUC General Order (G.O.):

- **Operated at an airport without an airport permit and failed to follow airport rules and regulations in violation of Pub. Util. Code Section 5381 and G.O. 157-E, Part 3.02. [2 counts]**

G.O. 157-E, Part 3.02 states in part that “No carrier shall conduct any operations on the property of or into any airport unless such operations are authorized by both this Commission and the airport authority involved.”

On November 7, 2025, SFO GTU issued Exquisite Transportation Administrative Citation #102801 [**Attachment 1**] for soliciting passengers and operating without an airport permit. Subsequently, on November 14, 2025, SFO GTU issued Exquisite Transportation Administrative Citation #104702 [**Attachment 2**] for soliciting passengers and operating without an airport permit. My investigation disclosed that Exquisite Transportation operated for two days without an airport permit.

- **Engaged one employee-driver without evidence of Workers’ Compensation (WKCP) insurance coverage in effect and on file with the CPUC, in violation of Pub. Util. Code Section 5378.1. [2 counts]**

On November 7, 2025, and November 14, 2025, [REDACTED] was observed operating on behalf of Exquisite Transportation at SFO. However, he is not listed as a member on Exquisite Transportation’s Statement of Information [**Attachment 3**]. In addition, records from the CPUC’s Transportation and Licensing Analysis Branch (TLAB) indicate that Exquisite Transportation has no employees on file and does not maintain an active Workers’ Compensation (WKCP) insurance policy on file and in effect with the CPUC [**Attachment 4**]. My investigation disclosed that Exquisite Transportation operated for two days without evidence of WKCP insurance.


