#### VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities (Pub. Util.) Code and a Commission General Order (G.O.) as described below. These violations occurred during the period January 1, 2023, through August 8, 2023.

- Engaged 10 employee-drivers without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1 [1 count];
- (2) Failed to enroll 10 employee-drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) program, in violation of Pub. Util. Code Sections 5374(a)(1)(D), 5381, G.O. 157-E Part 5.02 [10 counts];
- (3) Failed to enroll 10 employee-drivers in the Controlled Substance and Alcohol Testing Certification Program for pre-employment testing, in violation of Pub. Util. Code Sections 5374(a)(1)(I) and 5381, and G.O. 157-E, Part 10 [10 counts];
- (4) Failure to maintain and produce records in violation of Pub. Util. Code Sections 5389, 5381, G.O. 157-E, Part 6.01 and G.O. 157-E, Part 6.02 [1 count].

#### **STATEMENT OF FACTS**

The above violations are documented in the attached Investigation Report, which consists of the carrier's records and substantiating documents obtained from other sources.

#### **RESPONSE**

You are hereby called upon to answer this citation on or before February 2, 2024. By way of such answer, you may either:

- Pay a fine of \$20,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, or
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See the attached document "*How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal.*"

If you fail to respond by February 2, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

#### **INTRODUCTION**

On July 28, 2023, I was assigned to investigate the operations and practices of ERO Transportation, Inc., TCP 39308 B (hereinafter referred to as ERO) due to a Los Angeles International Airport Police Department ((LAXPD) complaint alleging that ERO was operating with a suspended authority and was involved in unfair business practices at LAX.

#### VIOLATIONS

I investigated ERO for the period of January 1, 2023, through August 8, 2023, and found violations of the following provisions of the Public Utilities (Pub. Util.) Code and the Commission General Order (G.O.):

### • Engaged 10 employee-drivers<sup>1</sup> without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1. [1 count]

Pub. Util. Code section 5378.1. states in part, "A statement under penalty of perjury, stating that, in its operations as a charter-party carrier, it does not employ any person in any manner so as to become subject to the workers' compensation laws of this state."

On July 28, 2023, Eric Hooks, Program Project Supervisor of the Transportation Enforcement Branch (TEB) sent a Data Request letter to Uber, via the California Public Utilities Commission's (CPUC) secured Kiteworks database, requesting waybills generated by ERO during the review period [Attachment 1]. Uber responded via Kiteworks, providing a

spreadsheet showing ERO had 10 employee-drivers [Attachment 2 shows a sample of entries in a spreadsheet]. The Commission's Transportation Licensing and Analysis Branch (TLAB) records show that ERO has never had an active WKCP insurance policy in effect and on file with the Commission. ERO completed and signed a WCKP Declaration form and Driver Statement of Applicant form stating ERO has no employees and has only one driver [Attachment 3]. My investigation disclosed that ERO operated for 4 days and completed 78 trips without evidence of WKCP insurance [Table 1 and Attachment 2].

• Failed to enroll 10 employee-drivers in the Department of Motor Vehicles (DMV) Employer Pull Notice (EPN) program, in violation of Pub. Util. Code Sections 5374(a)(1)(D), 5381, and G.O. 157-E Part 5.02 [10 counts]

A search of ERO's DMV EPN program with requester code shows ERO has been enrolled in the program since December 9, 2019. The program does not list the 10 employeedrivers listed in **Table 1 and Attachment 2** as being enrolled. My investigation disclosed that ERO operated with 10 employee-drivers for 4 days and completed 78 trips without being enrolled into ERO's DMV EPN program [**Table 1, Attachment 4, Footnote 1**]. • Failed to enroll 10 employee-drivers in the Controlled Substance and Alcohol Testing Certification Program for pre-employment testing, in violation of Pub. Util. Code 5374(a)(1)(I) and 5381, and G.O. 157-E, Part 10. [10 counts].

All charter-party carrier applicants who propose to employ any driver who will operate a vehicle having a seating capacity of 15 persons or less, including the driver, must provide for a mandatory controlled substance and alcohol testing certification program for those drivers as required by the G.O. unless all such drivers are already covered by federal testing regulations.

ERO's records show that it contracts with New Era Drug Testing LLC (hereinafter New Era). On December 4, 2023, a Data Request was sent to New Era requesting ERO's drivers' enrollment information for the review period. On December 5, 2023, New Era responded to the Data Request. New Era stated that ERO enrolled into their program on July 16, 2020, and had their program terminated on July 6, 2023. New Era stated only Armine Manvelyan was enrolled in their program from July 17, 2020, through July 6, 2023. New Era verified that the 10 employee-drivers listed in **Table 1 and Attachment 2** have never enrolled in ERO's drug program. My investigation disclosed that ERO operated with 10 employee-drivers for 4 days and completed 78 trips without being enrolled into ERO's drug program [**Table 1, Attachment 5, Footnote 1**].

#### • Failed to maintain and produce records in violation of Pub. Util. Code sections 5389, 5381, G.O. 157-E, Part 6.01, and G.O. 157-E, part 6.02. [1 count]

On August 8, 2023, I emailed a Cease and Desist (C&D) Notice and Data Request to ERO's email address and associated email addresses according to its Salesforce account. Main Email address: <u>erotransportation@gmail.com</u>. Email addresses associated with the carrier: <u>ellaalaverdian@yahoo.com</u>; <u>iskubr@gmail.com</u>; <u>arsenpetrosian42@gmail.com</u>; jimmycruz@yahoo.com; <u>armikno@mail.ru</u>; <u>isolimo7979@gmail.com</u>. On August 9, 2023, via U.S. Mail, I sent a C&D Notice and Data Request to the ERO's mailing, business, and terminal address, according to its Salesforce Account. ERO Transportation, Inc. Attn: Armine Manvelyan, Ovsep Sarafyan, & Karolina Alaverdyan, [Attachment 6]. On August 23, 2023, I called ERO at phone number, (818) 402-5402 and spoke to Armine Manvelyan, CEO, CFO and Secretary of ERO. I advised Ms. Manvelyan that I sent a C&D Notice and Data Request via email and by U.S. Mail. Armine Manvelyan stated she did not receive the documents. I asked Ms. Manvelyan if the company's email address and mailing address stated on their Salesforce account were correct. Ms. Manvelyan stated that the email and mailing address were correct. I advised Ms. Manvelyan about the C&D Notice which states to stop operating due to ERO's authority being suspended. Ms. Manvelyan stated that ERO is not operating. I advised Ms. Manvelyan about the Data Request and the requirement for the company to send me its business records by the deadline of August 23, 2023. Ms. Manvelyan stated that she would try to find and review the Data Request that I sent ERO on August 8, 2023. Ms. Manvelyan stated she would call me back after reviewing the Data Request.

On August 31, 2023, I called ERO Transportation, Inc. at (818) 402-5402. I spoke with Armine Manvelyan, and she stated that ERO did not receive the documents I sent on August 8th by email and on August 9th by U.S. Mail. I advised Ms. Manvelyan that the email addresses and mailing address that were provided by ERO on its Salesforce Account were the email addresses and mailing address I used to send ERO its C&D and Data Request. I advised Ms. Manvelyan that no email or mail was returned to me. Ms. Manvelyan asked for my email address and asked me to respond to her email by resending ERO's C&D and Data Request. I received Ms. Manvelyan's email, which is the same email on ERO's Salesforce account, erotransportation@gmail.com. I resent the C&D and Data Request to Ms. Manvelyan. Ms. Manvelyan stated she received the C&D and Data Request and stated she never received them earlier [Attachment 7]. Ms. Manvelyan stated that she needed time to provide the business documents requested in the Data Request. Ms. Manvelyan stated that she would be leaving the country to have a medical procedure performed and would have her accountant work on the Data Request. I provided a final deadline of September 15, 2023. Ms. Manvelyan emailed me a copy of the Cancellation Request/Policy Release form from ERO's insurance company, a copy of an invoice and two past drug result tests from her drug consortium, and a copy of ERO'S vehicle registration. No other documentation was provided.

On September 18, 2023, I called ERO at (818) 402-5402 and left a message stating the deadline to respond to the Data Request and to submit ERO's business records was September

15, 2023. I stated that if ERO does not contact me as soon as possible, then I will move forward with issuing a citation to ERO.

On September 20, 2023, I emailed ERO using the email address, erotransportation@gmail.com. I reiterated in my email the deadline to submit ERO's business records was September 15, 2023. I stated that if ERO fails to respond then I will move forward with a citation [Attachment 8].

On September 25, 2023, I emailed ERO stating that I had not heard from Armine Manvelyan or any person representing ERO **[Attachment 9]**. I stated that ERO would be cited for failure to produce and maintain its company's business records. ERO's non-response shows it will not in good faith cooperate with the Commission's Data Request.

On July 28, 2023, a Data Request letter was sent by Eric Hooks, Program Project Supervisor of TEB to Uber asking to provide waybills generated by ERO during the review period [Attachment 1]. Uber responded and provided a waybill spreadsheet showing ERO had operated 144 days and conducted 136,219 trips [Attachment 2 shows a sample of entries in the spreadsheet, Footnote 1]. My investigation disclosed that ERO failed to maintain and produce its records by not providing any of its waybills, income tax returns, or other business records to reconcile the information provided by Uber.

#### DECLARATION

I have read the foregoing and know the contents thereof and I declare under penalty of perjury that the foregoing is true and correct, except as to those matters stated on information and belief, and to those matters, I believe to be true.

- 1. Provide a narrative explanation summarizing the alleged fraudulent activity investigated by Uber.
- 2. Please provide any and all documents related to Uber's internal investigation into the allegations of fraudulent activities.
  - a. Include all fraudulent information and documents submitted to Uber (e.g., registrations, Charter-party carrier (TCP) permits and/or certificates, insurance documents, drivers' licenses, etc.) discovered by Uber as part of its investigation.
- 3. Provide the names of all individuals at Uber responsible for carrying out the investigation, including management responsible for oversight of the investigation.
- 4. If this matter was referred to or investigated by any other state or federal agency, please identify the agency, proceeding number, and contact information for the agency.
- 5. Please provide an Excel spreadsheet identifying the name of each Uber <u>employee</u> involved, the specific allegation(s) against each employee (including whether the employee violated Uber policies, Commission, or other legal authorities), the time frame of the allegations, any actions taken in response by Uber, and the date the action was taken with respect to each employee.
- 6. **Question 1**: Provide a narrative explanation summarizing the alleged fraudulent activity investigated by Uber.

- Summarized the alleged violations around LAX.
  - LAX Police Department shared a driver's allegations:
    - Vehicles operating without commercial license plates.
    - Uber Black drivers skipping TCP queues.
    - Vehicles that should be deactivated are operating.
    - Fake Uber Black accounts.

**Question 2**: Please provide any and all documents related to Uber's internal investigation into the allegations of fraudulent activities.

- a) Include all fraudulent information and documents submitted to Uber (e.g., registrations, Charter-party carrier (TCP) permits and/or certificates, insurance documents, drivers' licenses, etc.) discovered by Uber as part of its investigation.
  - Copy of LAX PD complaint
  - Fleet documents (pictures of vehicle registrations)

**Question 3**: Provide the names of all individuals at Uber responsible for carrying out the investigation, including management responsible for oversight of the investigation.

• Provided 12 names.

**Question 4**: If this matter was referred to or investigated by any other state or federal agency, please identify the agency, proceeding number, and contact information for the agency.

- Uber has referred the issue to the FBI.
   <u>Special Agent Mark Newhouse</u>, FBI Los Angeles Field Office,
- The U.S. Department of Justice has opened a grand jury investigation.

**Question 5**: Please provide an Excel spreadsheet identifying the name of each Uber employee involved, the specific allegation(s) against each employee (including whether the employee violated Uber policies, Commission, or other legal authorities), the time frame of the allegations, any actions taken in response by Uber, and the date the action was taken with respect to each employee.

- Uber identified three employees and two third-party contractors. The employees are no longer employed, and the contractors' assignments were terminated.
- Uber provided the names of the employees and contractors.

**Question 6**: Please provide an Excel spreadsheet identifying the passenger-carriers involved in the fraudulent activities, including the following information: individual carrier names, owner names, doing business as names, actions taken by Uber with respect to the carrier, and date the actions were taken, and expected completion date of the action.

• Uber has provided a spreadsheet with the information. Uber identified 43 carriers. A driver was deactivated from one carrier while the other carriers' fleets have been deactivated.

**Question 7**: Please provide the names of each passenger-carrier (carrier) involved in the fraudulent activities at LAX and provide copies of corresponding waybills from the initial date of fraudulent activity to current. Responsive waybills shall include, at a minimum, records from January 1, 2022, to current. In lieu of actual waybills, Uber may provide a spreadsheet including all waybill information per Commission General Order 157-E Part 3.01.

- Subcarrier referenced in the LAX PD complaint and determined to have submitted fraudulent documents to Uber:
  - ERO Transportation Inc. (PSG 0039308)
  - AMR77 Corporation (PSG 0038984)
  - VIP77 Transportation Services Inc. (PSG 0041087)
  - Tikero Group Inc. (PSG 0039467)
  - Picazo Limo LLC (PSG 0040668)
- Uber provides waybill information for the subcarriers listed above.

**Question 8**: Provide any sub-carrier agreements between Uber and the sub-carrier for those carriers involved in the fraudulent activity per Commission General Order 157-E Part 3.04. If a subcarrier employed or contracted with affiliates, please identify all affiliates connected to each subcarrier and their associated drivers, and provide the subcarrier agreement between the subcarrier and its affiliates.

- Provided a copy of the most current subcarrier agreement ("Platform Access Agreement") between Uber and the subcarriers involved in the fraudulent activity.
- Uber is not aware of whether subcarriers contracted with affiliates.

**Question 9**: Please provide all new or existing internal and external control measures, policies or procedures that have been implemented to prevent or deter future fraudulent employee activity.

- Members of the Community Operations team undergo specific training related to fraud and document approvals.
- Uber restricts access to fleet partner accounts so that only select employees can approve documents submitted and take certain account actions.
- Greenlight Hub agents are no longer permitted to approve certain fleet level documents in California.
- Uber provided copies of their employee training and policy documents (17 documents).

**Question 10**: Please provide all new or existing internal and external control measures, policies, procedures that have been implemented to prevent or deter future fraudulent subcarrier activity.

- Uber is working to improve processes to detect and prevent altered documents by subcarriers:
  - Updating document review processes to include a barcode scan and second-layer review of all vehicle registration documents.
  - Requiring agents perform a double entry of VIN and license plate information.
  - Implementing a specialized review by trained agents for insurance certificates.
  - Uber plans to implement a secondary fraud review process for identity documents utilizing fraud detection tools and specialized agents.
  - Updating document review guidance for agents.
  - Changing access controls on fleet partner accounts internally at Uber.
  - Tracking subcarriers who submitted altered documents to prevent the same TCP entity from re-onboarding.
  - Actively monitoring existing fleet activity to detect suspicious activity.







Dear: ERO Transportation, Inc.,

On July 16, 2023, your charter-party carrier of passengers (TCP) operating authority was suspended for failure to maintain Public Liability and Property Damage (PL&PD) insurance and failure to pay quarterly fees (PUCTRA) Q1 2023.

This letter places you on notice to cease and desist immediately all advertisements and operations as a charter-party carrier of passengers without valid authority in force with the Commission. Continued violations may result in criminal prosecutions and termination of telephone service.

The Commission regulates and licenses charter-party carriers of passengers within California pursuant to the California Constitution. Public Utilities Code (P.U. Code) Sections 5411, 5414.5 and 5415 state that any carrier which operates and/or advertises without authority is guilty of a misdemeanor which is punishable by a minimum fine of \$1,000 or by imprisonment in the county jail for up to three months, or both. Each day of continued violations is a separate and distinct offense.

The California Public Utilities Commission's (Commission) Consumer Protection and Enforcement Division (CPED) Transportation Enforcement Branch (TEB) is currently reviewing the Commission's records for intrastate transportation carriers that are regulated by the Commission.

Public Utilities Code Section 5389 authorizes the Commission and its staff to have access at any time to the land, buildings, or equipment of a charter-party carrier of passengers used in connection with the operation of its business and may inspect the accounts, books, papers, and documents of the carrier.

General Order 157-E, Part 6.01 specifically states in part that every carrier shall institute and maintain in its offices a set of records which reflect information as to the transportation services performed, including waybills, driver records, and safety and maintenance records including copies of all lease and sub-carrier agreements. Such records shall be maintained for a minimum period of three years.

Pursuant to Public Utilities Code Section 5389, the Commission is requesting a review of the Charter-Party intrastate transportation records for ERO Transportation, Inc. Failure to provide access to records is a misdemeanor punishable by a maximum of \$5,000, or by imprisonment in a county jail not exceeding one year, or by both fine and imprisonment, where each violation is a separate and distinct offense (Public Utilities Code Section 2110).

# NOTICE TO CEASE AND DESIST

Dear: ERO Transportation, Inc.,

On July 16, 2023, your charter-party carrier of passengers (TCP) operating authority was suspended for failure to maintain Public Liability and Property Damage (PL&PD) insurance and failure to pay quarterly fees (PUCTRA) Q1 2023.

This letter places you on notice to cease and desist immediately all advertisements and operations as a charter-party carrier of passengers without valid authority in force with the Commission. Continued violations may result in criminal prosecutions and termination of telephone service.

The Commission regulates and licenses charter-party carriers of passengers within California pursuant to the California Constitution. Public Utilities Code (P.U. Code) Sections 5411, 5414.5 and 5415 state that any carrier which operates and/or advertises without authority is guilty of a misdemeanor which is punishable by a minimum fine of \$1,000 or by imprisonment in the county jail for up to three months, or both. Each day of continued violations is a separate and distinct offense.

P.U. Code Section 5379 states that it is unlawful for any carrier to operate after suspension or revocation of its operating authority. This letter places your company on notice that continued violations of the law without the required authority may result in criminal prosecutions and possible termination of telephone service. There will be no further warnings.

Dear ERO Transportation, Inc.:

The California Public Utilities Commission's (Commission) Consumer Protection and Enforcement Division (CPED) Transportation Enforcement Branch (TEB) is currently reviewing the Commission's records for intrastate transportation carriers that are regulated by the Commission.

Public Utilities Code Section 5389 authorizes the Commission and its staff to have access at any time to the land, buildings, or equipment of a charter-party carrier of passengers used in connection with the operation of its business and may inspect the accounts, books, papers, and documents of the carrier.

General Order 157-E, Part 6.01 specifically states in part that every carrier shall institute and maintain in its offices a set of records which reflect information as to the transportation services performed, including waybills, driver records, and safety and maintenance records including copies of all lease and sub-carrier agreements. Such records shall be maintained for a minimum period of three years.

Pursuant to Public Utilities Code Section 5389, the Commission is requesting a review of the Charter-Party intrastate transportation records for ERO Transportation, Inc. Failure to provide access to records is a misdemeanor punishable by a maximum of \$5,000, or by imprisonment in a county jail not exceeding one year, or by both fine and imprisonment, where each violation is a separate and distinct offense (Public Utilities Code Section 2110).

We are requesting that you present your documents listed below in electronic form. Please scan the following documents and email a copy to Aaron Pete at aaron.pete@cpuc.ca.gov by August 23, 2023.

- 1. All waybills/trip logs for transportation performed from January 1, 2023, through August 8, 2023.
- 2. Department of Motor Vehicle (DMV) registrations and list of all equipment operated (owned, leased, or rented).
- 3. DMV Employer Pull Notice (EPN) records for drivers enrolled and/or deleted.
- 4. List of all drivers and their respective driver's license numbers, including dates hired and if still currently driving.
- 5. Your current Public Liability and Property Damage (PL&PD) insurance policy showing schedule of vehicles and drivers insured.
- 6. Your current Workers' Compensation (WKCP) insurance policy, if applicable.
- 7. List of all current sub-carriers and agreements.
- 8. Current service agreement with your Drug Consortium and a list of all drivers enrolled showing dates added and/or deleted.
- 9. Last three (3) years of filed Federal and State Income Tax Returns.
- 10. Bank statements and cancelled checks.
- 11. All other transportation records pertaining to ERO Transportation, Inc.'s operations which are not specifically noted above.

CPED reserves the right to amend, add to or revise this Data Request in the future if necessary.

Any responsive records provided by you that have been properly labeled and submitted as confidential will be treated as such under Public Utilities Code Section 583 (see also General Order 66-D). Confidential documents will not be released to the public except as required by law following a Public Records Request and redaction of confidential material.
