

VIOLATIONS

You are hereby cited with having violated section(s) of the Public Utilities (Pub. Util.) Code Commission General Orders (G.O.) as described below. These violations occurred during the period of June 1, 2023, through January 11, 2024.

- (1) Operated as a charter-party carrier after the revocation of its authority, in violation of Pub. Util. Code Section 5379, [1 count];
- (2) Engaged one employee-driver without evidence of Workers' Compensation (WCKP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1, [1 count];
- (3) Operated as a charter-party carrier without evidence of Public Liability and Property Damage (PL&PD) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5391 and G.O. 115-F and 157-E, Part 1.05, [1 count]; and
- (4) Advertised as a charter-party carrier without a valid authority, in violation of Pub. Util. Code Section 5414.5, [1 count].

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

You are hereby called upon to answer this citation on or before April 15, 2024. By way of such answer, you may either:

- (1) Pay a fine of \$6,000 pursuant to P.U. Code Section 5378. (Submit your check or money order payable to California Public Utilities Commission using the attached *Citation Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed, **or**
- (2) Contact the Supervisor below to make payment arrangements, or
- (3) Contest this Citation by filing an Appeal. See the attached document "How to File an Appeal and Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal."

If you fail to respond by April 15, 2024, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On October 4, 2023, I was assigned to investigate the operations and practices of Five Star Limousine of LA LLC (hereinafter referred to as Five Star) because of a consumer complaint alleging that Five Star is operating without an authority.

HISTORY OF ENFORCEMENT

Enforcement case records show that Five Star has a history of violating Commission rules and regulations, as detailed below.

Prior Case (PSG-4782): On November 8, 2018, California Public Utilities Commission's (CPUC) Transportation Enforcement Analyst, Charley Park, issued Five Star Citation # F-5495 in the amount of \$2,000 [Attachment 1] for the following violations:

- Failed to enroll a driver in the Department of Motor Vehicle (DMV) Employer Pull Notice (EPN) Program;
- Failed to maintain and enroll a driver in a mandatory Controlled Substance and Alcohol Testing Certification Program for Pre-Employment Testing;
- Conducted operations at Los Angeles International Airport (LAX) without a valid airport authorization, and;
- Failed to report accurate Public Utilities Commission Transportation Rate Account (PUCTRA) fees for the years 2015, 2016, and 2017.

VIOLATIONS

I investigated Five Star for the review period of June 1, 2023, to January 11, 2024, and found violations of the following provisions of the Public Utilities (Pub. Util.) Codes and Commission General Orders (G.O.):

 Operated as a charter-party carrier after revocation of its authority, in violation of Pub. Util. Code Section 5379. [1 count] A review of the CPUC's Transportation Licensing and Analysis Branch (TLAB) records show that Five Star was issued via U.S. mail an Order of Suspension on November 7, 2018, for failure to resolve underpayment of quarterly fees for the fourth quarter (Q4) of 2017. The suspension order states that unless Five Star corrects this by December 7, 2018, the suspended operating authority will be revoked [Attachment 2]. Five Star failed to correct the deficiency and was issued via U.S. mail an Order of Revocation on December 7, 2018, for failure to resolve underpayment of quarterly fees for Q4 of 2017 [Attachment 3].

A review of the complainant's Five Star Contract for Service showed Five Star provided transportation service on June 3, 2023 [Attachment 4].

On October 25, 2023, I sent Five Star a Notice to Cease and Desist (C&D) via e-mail and by U.S. Postal Service regular mail [Attachment 5].

My investigation disclosed that Five Star operated for one day and conducted one trip after the revocation of its authority.

• Engaged one employee-driver without evidence of Workers' Compensation (WKCP) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5378.1. [1 count]

Pub. Util. Code Section 5378.1 states in part, "A statement under penalty of perjury, stating that, in its operations as a charter-party carrier, it does not employ any person in any manner so as to become subject to the workers' compensation laws of this state."

The CPUC's TLAB records show that Five Star's WKCP insurance with State Compensation Insurance Fund, Policy # ______, was canceled on July 24, 2022. My investigation disclosed that Five Star operated for one day and conducted one trip after the cancellation of WKCP insurance [Attachment 6].

• Operated as a charter-party carrier without evidence of Public Liability and Property Damage (PL&PD) insurance coverage in effect and on file with the Commission, in violation of Pub. Util. Code Section 5391 and G.O. 115-F and 157-E, Part 1.05. [1 count]

TLAB records show that Five Star's PL&PD insurance with Philadelphia Indemnity Insurance Company, Policy # ______, was canceled on February 27, 2019. Five Star's current PL&PD insurance with National Liability & Fire Insurance Company, Policy # ______, was effective on June 10, 2023. My investigation disclosed that Five Star operated for one day and conducted one trip after the cancellation of its PL&PD insurance [Attachment 7].

• Advertised as a charter-party carrier without a valid authority, in violation of Pub. Util. Code Section 5414.5. [1 count]

A search on the internet on January 11, 2024, shows Five Star advertised intrastate transportation services on their website (https://5starlimoofla.com/) [Attachment 8].

NOTICE TO CEASE AND DESIST

Dear Mr. Gartchian:

On November 7, 2018, your Charter-Party Carrier (TCP) operating authority was suspended for failure to resolve underpayment of quarterly fees for the fourth quarter of 2017. It was subsequently revoked on December 7, 2018.

This letter places you on notice to cease and desist immediately all advertisements and operations as a TCP without valid authority in force with the Commission. Continued violations may result in criminal prosecutions and termination of telephone service.

The Commission regulates and licenses TCPs within California pursuant to the California Constitution. Public Utilities Code (P.U. Code) Sections 5411, 5414.5 and 5415 state that any carrier which operates and/or advertises without authority is guilty of a misdemeanor which is punishable by a minimum fine of \$1,000. Each day of continued violations is a separate and distinct offense.

P.U. Code Section 5379 states that it is unlawful for any carrier to operate after revocation of its operating authority. This letter places your company on notice that continued violations of law without the required authority may result in criminal prosecutions. There will be no further warnings.






