**NOTICE OF AVAILABILITY OF
PACIFIC GAS AND ELECTRIC COMPANY’S (U 39 G) RESPONSE TO
ADMINISTRATIVE LAW JUDGES’ RULING DIRECTING GAS
UTILITIES TO PROVIDE GAS DISTRIBUTION COST DATA**

Pursuant to the Administrative Law Judges’ Ruling Directing Gas Utilities to Provide Gas Distribution Cost Data (Ruling), issued on September 24, 2025, Pacific Gas and Electric Company (PG&E) provides this Notice of Availability of its three completed gas distribution cost data templates described in the Ruling, which PG&E filed with the Commission today, November 5, 2025.

Specifically, the Ruling directs in part as follows: “...By November 5, 2025, PG&E [and the other California gas utilities] shall publish the data on their respective SB 1221 webpages and file in the docket of this proceeding a ‘Notice of Availability’ of the secure download link...”¹

In compliance with the Ruling, PG&E has provided a secure download link below for the following three completed gas distribution cost data templates, which are available on PG&E’s SB 1221 webpage in MS Excel format:

- Distribution Replacement Costs Data-PG&E
- RegStation Replacement Costs Data-PG&E
- Maintenance Costs-PG&E

These completed gas distribution cost data templates do not contain confidential information. To access the completed templates on PG&E’s SB 1221 webpage (both the public version of PG&E’s SB 1221 webpage and the confidential version of the webpage for those
