To the parties of R.25-08-004, R.17-07-007 and R.11-09-011:

On July 24, 2026, CALSSA submitted the PETITION OF THE CALIFORNIA SOLAR & STORAGE ASSOCIATION TO MODIFY RESOLUTION E-5357 TO ADOPT IEEE 2030.5.100 TEST PROCEDURE FOR SMART INVERTERS, attached, to the CPUC Energy Division and served it to the service lists for Rulemaking (R.) 17-07-007 and R.11-09-011.

Consistent with the CPUC's Rules of Practice and Procedure 16.4, responses to petitions for modification must ordinarily be submitted within 30 days of the date that the petition was filed. However, in this instance the Energy Division is extending the deadline by 22 calendar days. The additional time is being provided because the response instructions are being issued 20 days into the ordinary response period. Hence, responses to CALSSA's July 24, 2026, petition must be submitted by close of business on September 14, 2026. Responses must be served on the petitioner and on all parties to R.25-08-004, R.17-07-007 and R.11-09-011. Responses should be served but not filed with the CPUC docket office.

Note that the Petition for Modification (PFM) remains an informal matter before Energy Division and has not been incorporated into R.25-08-004. Service on the R.25-08-004 list is for additional notice and does not incorporate the PFM into that proceeding. Responses should be submitted to Energy Division, served on CALSSA and the designated recipients, and submitted by the deadline set above.

The Energy Division will not accept replies to responses.
