# CPUC Opens Public Inquiry on High Winter Natural Gas Prices

he California Public Utilities Commission (CPUC) has continued its work to examine the causes of recent high natural gas prices on the wholesale markets by launching a new proceeding to investigate the causes and impacts of the winter 2022- 2023 natural gas price spikes and the potential for recurrence; the impact of the price spikes on natural gas and electric prices and customer bills; the potential threats to natural gas and electric reliability and price volatility in summer 2023 and beyond, and potential mitigations; and utility communications to customers to determine whether they were sufficient or require modifications.

The wholesale price of natural gas in California, and throughout the Western U.S., has been extraordinarily high this winter, starting in late November 2022. In February 2023, natural gas prices trended downward but are still

high compared to February 2022. As a result, customers have seen higher bills from their utility company, which pass on the cost they pay for natural gas directly to the customer without a mark-up. High natural gas prices can have an immediate impact to customers, and also a delayed impact when electric rates increase because the natural gasrelated costs of running electric power plants are higher than earlier forecasts.

While the CPUC does not regulate natural gas prices or natural gas producers, given the impact of the high prices on utility customers, and given the role that natural gas plays in electricity production, upon seeing the price spikes in December 2022, the CPUC promptly took <u>several actions</u>. One of

### Southern California Gets New 738 Area Code to Overlay 213/323

The CPUC has ensured that telephone numbers continue to be available to meet the demand in the geographic region served by the 213 and 323 area codes by approving a third area code (called an overlay) that will provide additional numbering resources while minimizing customer inconvenience. The new area code to overlay the 213 and 323 area codes is 738.

The 213/323 area code serves downtown Los Angeles, Alhambra, Bell, Bell Gardens, Beverly Hills, Commerce, Cudahy, Glendale, Hawthorne, Huntington Park, Inglewood, Lynwood, Maywood, Montebello, Monterey Park, Pasadena, Rosemead, South Gate, South Pasadena, Vernon, West Hollywood, and unincorporated portions of Los Angeles County. It is projected to run out of available prefixes (the first three numbers after the area code in a telephone number) by June 2025. The CPUC's action today approves the request of the North American Numbering Plan Administrator, the neutral third-party area code relief planner for California, for an area code overlay to provide additional numbering resources to meet the demand for telephone numbers.

An area code <u>overlay</u> adds an additional area code to the geographic region served by the existing area code(s). Therefore, multiple area codes co-exist within the same geographic region. Existing 213/323 customers will retain their area code and specific telephone number(s). Customers will continue to dial the three-digit area code for all calls to and from telephone numbers with the 213, 323, and 738 area codes. The price of a call will not change due to the overlay. Customers can still dial just three digits to reach 911, as well as 211, 311, 411, 511, 611, 711, and 811.

Below are some tips to help prepare for the area code overlay:

- Contact security or alarm vendors to update dial-up numbers to avoid a break in security routines and contacts.
- Reprogram equipment or features, i.e., automatic dial, speed-dial, call

forwarding, modems for computer or Internet dial-up access, etc.

- Update items like stationery, checks, etc., to include your area code + tele-phone number.
- Provide your area code and telephone number, not just the telephone number, as needed.
- When asking for someone's number, remember to ask for the area code too.
- Remember that the previous area codes and the new area code will co-exist within the same geographic region.

The 213 area code was created in 1947 and was one of the original three area codes in California. The 213 area code was split five times between 1951 and 1991, creating the 714 area code in 1951, the 805 area code in 1957, the 818 area code in 1984, the 310 area code in 1991 and the 323 area code in 1998. In 2017, the CPUC approved an elimination of the boundary between the 213 and 323 area codes, creating the 213/323 overlay area codes. ■

# GET TO KNOW US: Meet David Van Dyken

David Van Dyken has been an Administrative Law Judge (ALJ) at the CPUC since October 2022. David joined the CPUC in January 2020 in the Safety Policy Division, where he served as the CPUC's first Access and Functional Needs Coordinator and later as a Senior Analyst working on wildfire mitigation, utility Public Safety Power Shutoffs, and risk analysis and mitigation phase work. He is the current chair of the CPUC's internal Disability Advisory Committee and a member of the Rainbow Regulators.

David came to the CPUC with 19 years of professional transportation planning experience working with the California Department of Transportation, California Transportation Commission, California High-Speed Rail Authority, and the Tuolumne County Transportation Council. David has a bachelor's degree in Social Sciences and master's degrees in Public Administration and Transportation Management. He lives in Sacramento, and recently shared more about himself in a Q&A:

## **QUESTION:** Can you tell us about your childhood and growing up?

**ANSWER:** I was born in La Mesa and grew up in Spring Valley, which is east of San Diego. I went to Monte Vista High School, the same high school my dad went to. Growing up in San Diego County we went to the beach, but I would spend more of my time hiking and camping in the Laguna Mountains and in Anza-Borrego Desert State Park. Every year, my Boy Scout troop did a canoeing weekend in Mission Bay and a 2-day canoe and camping trip down the Colorado River. To this day I am still very good at handling a canoe.

#### Q: What kind of music do you enjoy? Who are your favorite musicians or groups? Do you sing or play an instrument?

A: My musical tastes are varied. I enjoy jazz, classical, classic rock, alternative rock, and 80s music. Some of my favorite groups are the Red Hot Chili Peppers, Radiohead, Pearl Jam, Pink Floyd, and Led Zeppelin. I don't play any musical instruments. You don't want to hear me sing either.

## **Q:** What activities do you enjoy doing in your free time?

A: I enjoy bicycling, hiking, reading, and watching documentaries. For most of the past 12+ years, I've participated in historical reenactments at the Old Sacramento Historic Cemetery. In the two weekends prior to Halloween, visitors are led on a guided tour through the cemetery at night where they meet various people who are buried there. The spirits (actors) tell their stories of how they lived and died.

### **Q:** Do you have a memorable travel story?

A: One of my goals in life is to visit every county and county equivalent in the U.S. (there are currently 3,143 and I've been to 620). In 2008 I was driving my pickup truck along US-50 through Nevada, nicknamed the "Loneliest Road in America." You can get a Loneliest Road passport, and if you get it stamped in each of the 5 towns on the route, you get a certificate from the governor of Nevada saying that you've survived the Loneliest Road, as well as a medal and keychain. Between Fallon and Austin, Nevada, I took a detour off US-50 to an even more remote highway called Nevada State Route 722. A few miles outside of Austin, I was joined



by several hundred head of cattle crossing the highway and walking along it. It took about 30 minutes to navigate through and past the cattle that were walking alongside and in front of my truck. When I finally made it to Austin, I found a very rustic but comfortable motel room. The bathroom was wallpapered with newspaper advertisements from the early 1900s. There was no closet but there was an antler on the wall to hang clothes.

# Q: If you had to pick one book to recommend to a friend to read, what book would it be and why?

A: One book that kept my interest was "Skeletons on the Zahara," written by a maritime historian named Dean King. It is a true story of a group of American sailors who were shipwrecked off the coast of Africa's Sahara Desert in 1815. The author wrote the book in 2004 from biographical accounts of the survivors. It is recommended reading because, although some of the endurances are disturbing, it was an event that at one time was very well-known in the U.S. but has since slipped out of the American consciousness.

#### PUBLIC INQUIRY ON HIGH WINTER NATURAL GAS PRICES continued from page 1

which was to hold a public En Banc on Feb. 7 at which important data was gathered. For example, the California Energy Commission (CEC) presented price comparisons between this winter and last winter, showing that natural gas prices for delivery on December 22, 2022, were nearly seven times higher compared to the same day in 2021. Additionally, the CEC showed that the price spikes were not unique to California and were experienced in other Western states. The examination in the proceeding opened March 16, 2023 (formally called an <u>Order Instituting Investi-</u> gation), will include whether factors beyond normal market forces were at play, determine whether action by the CPUC may prevent or mitigate future price spikes, and consider whether other entities have jurisdiction to mitigate high natural gas prices.

The public can submit comment on the proceeding's <u>Docket Card</u>.

In further actions, Governor Gavin Newsom and other elected representatives have written to the Federal Energy Regulatory Commission (FERC) asking it to investigate whether market manipulation, anticompetitive behavior, or other anomalies have contributed or are contributing to the high prices seen throughout the West this winter. In response, FERC stated that it is conducting surveillance to determine whether any market participants engaged in behavior that contributed to, or took advantage of, the high gas prices.
