# NOTICE OF APPLICATION Liberty Utilities (CalPeco Electric) LLC's Request to Increase Electric Rates APPLICATION 25-06-017

### Why am I receiving this notice?

On June 20, 2025, Liberty Utilities (CalPeco Electric) LLC (Liberty) filed its Wildfire Expense Memorandum Account (WEMA) Application (A.25-06-017) with the California Public Utilities Commission (CPUC). The application is requesting a total of \$78.218 million.

If the CPUC approves this application, Liberty will recover authorized costs in electric rates over a threeyear period beginning after a Decision is reached in this proceeding. This will increase your monthly bill.

## Why is Liberty requesting this rate increase?

- Liberty is submitting this application seeking authority to recover in rates incremental costs in its WEMA related to the 2020 Mountain View Fire.
- The request includes costs to resolve third-party claims arising from the Mountain View Fire, as well as associated legal and financing costs.
- In California, utilities are required to pay for property damage and other costs resulting from a fire associated with utility facilities even if they operated their systems prudently. The CPUC then reviews those costs before allowing these costs to be recovered in rates.

#### How could this affect my monthly electric rates?

If Liberty's rate request is approved by the CPUC, the average residential monthly bill using 669 kWh per month would increase by approximately \$29.78 or 15% per month in 2026-2028.

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt Liberty's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate

decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review Liberty's application, including the Public Advocates Office which is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels.
