# SAN DIEGO GAS & ELECTRIC NOTIFICATION OF REQUEST TO RECOVER COSTS RECORDED IN THE TRANSMISSION INTEGRITY MANAGEMENT PROGRAM BALANCING ACCOUNT A.25-02-012

#### Why am I receiving this notice?

On February 27, 2025, San Diego Gas & Electric (SDG&E<sup>®</sup>) filed an application (A.25-02-012) with the California Public Utilities Commission (CPUC) to recover costs recorded in the Transmission Integrity Management Program Balancing Account (Application). The Application seeks to recover a total revenue under-collection of \$7.4 million.

# Why is SDG&E requesting this rate increase?

This Application will cover the implementation of the Transmission Integrity Management Program (TIMP), and recovery of related costs recorded in the TIMP Balancing Account (TIMPBA) from 2019-2023. TIMP is a comprehensive program that performs prescriptive assessments on natural gas transmission pipelines as required by federal regulations, including the new federal regulations that were enacted over the 2019-2023 timeframe.

The CPUC approved the TIMP with approximately \$84.5 million of authorized expenditures for the years 2019-2023. SDG&E is requesting recovery of \$7.4 million in under-collected revenue, for expenditures that were incurred above authorized levels for the period of August 1, 2023, through December 31, 2023.

# How could this affect my monthly gas bill?

If SDG&E's rate request is approved by the CPUC, the average residential monthly bill using 25 therms per month would increase by approximately \$0.02 or 0.03% per month over a 12-month period, or until the costs are recovered. The proposed average rates shown below are for 2026.

### How does the rest of this process work?

This Application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SDG&E's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.
