Thank you for your January 24, 2022 letter encouraging investor-owned utilities to apply for federal funding under the Infrastructure Investment and Jobs Act (IIJA). Pacific Gas and Electric Company (PG&E) appreciates the CPUC's efforts and shares your deep concern regarding affordability of electric and gas utility service and the impacts of the changing climate on our State. We are committed to aggressively pursuing these funding opportunities on behalf of our customers.
