Summary: SCE submits this report as it may involve an event that meets the fatality or personal injury rising to the level of in-patient hospitalization reporting requirement. Preliminary information indicates an employee of Herman Weissker, Inc., a contractor working for SCE, sustained burn injuries while working on a project to transfer conductors from an existing tower to a newly installed tubular steel pole (TSP). The Kramer-Cool Water 115 kV circuit was not energized at the time and there was no circuit activity as a result of this incident. Furthermore, we have no indication there was any property damage arising from the event. The individual was transferred from the scene via ambulance to Barstow Hospital and subsequently air-lifted to Loma Linda University Hospital. The investigation is on-going.
