On behalf of the Safety and Enforcement Division (SED) of the California Public Utilities Commission (CPUC), Randy Fienberg & Mohammed Noureddine conducted a General Order (GO) 112-F inspection of Southwest Gas Company (SWG) between May 22<sup>nd</sup> through May 26<sup>th</sup>, 2023. The inspection included a review of North Lake Tahoe, South Lake Tahoe & Truckee Districts' records for the period of 2018 through 2022, as well as a representative field sample of the facilities. SED staff also reviewed the operator qualification (OQ) records, which included field observations of randomly selected individuals performing covered tasks. The Pipeline and Hazardous Material Safety Administration's (PHMSA) Inspection Assistant (IA) was used as a reference guide to conduct the inspection.

SED's staff did not observe any probable violation of GO 112-F, Reference Title 49 Code of Federal Regulations (CFR), Part 192 and considers this inspection closed.
