SDG&E's records indicated that for the 5-year period ending on June 4, 2021, SDG&E did not assign a priority level and due date for corrective action for 7 work orders as required by SDG&E's own procedures.

IV. Field Inspection - Violations List

My staff observed the following violations during the field inspection portion of the audit:

GO 95, Rule 31.1, Design Construction and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

The following SCE transmission facilities required maintenance:

- Tower Z223165: The sign for the tie-line identification was starting to peel off.
- Pole Z33187: The High Voltage sign at the base of pole was vandalized/illegible and needed to be cleaned or replaced.
- Pole Z33188: The High Voltage sign at the base of pole was vandalized/illegible and needed to be cleaned or replaced.
- Pole Z33187: The tieline identification sign at the base of pole was vandalized/illegible and needed to be cleaned or replaced.
