# II. Field Inspection

My staff inspected the following structures during the field inspection portion of the audit.

Note: most, if not all, of the facilities owned by Crown Castle Communications did not have service drops providing service to customers, houses, or residential areas. Most of the Crown Castle Communications LA/OC service drops were installed to provide service to hospitals, businesses, etc. Also, a third party, such as AT&T, also shares joint agreements with Crown Castle Communications on certain facilities in the LA/OC service area.

## **III. Field Inspection - Violations List**

My staff observed the following violations during the field inspections portion of the audit:

# GO 95, Rule 18-A3, Resolution of Potential Violations of General Order 95 and Safety Hazards, states:

(3) If a company, while performing inspections of its facilities, discovers a Safety Hazard(s) on or near a communications facility or electric facility involving another company, the inspecting company shall notify the other entity of such safety hazard(s) no later than 10 business days after the discovery.

Safety hazards on the following poles were not documented and reported to the responsible thirdparties until during the audit.

- A third-party ground moulding attached to pole 6439 (Newport Beach, No. 9) was damaged.
- A third-party SCE down guy attached to pole 1267870E (Newport Beach No. 62) was touching communication conductors.

#### GO 95, Rule 31.1, Design, Construction and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

A Crown Castle Communications messenger wire attached to Pole 993239E was not taut.
