The audit included a review of Cox's inspection and maintenance records and a field inspection of Cox's facilities.

Audit Findings

I. Records Review

During the audit, my staff reviewed the following records:

- Overhead and underground detailed inspection records
- Patrol records
- Completed and pending corrective action work orders
- Safety hazard notifications
- Pole-loading calculations
- Cox's documented inspection program

II. Records Review - Violations List

GO 95, Rule 31.1, Design Construction and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

The pole load calculation for pole P186072 shows a span length in the direction of 162 and 167 degrees as 50 feet but the field measurement was approximately 30 feet.

GO 95, Rule 31.2, Inspection of Lines, states in part:

Lines shall be inspected frequently and thoroughly for the purpose of ensuring that they are in good condition so as to conform with these rules. Lines temporarily out of service shall be inspected and maintained in such condition as not to create a hazard.

GO 128, Rule 17.2, Inspection, states:

Systems shall be inspected by the operator frequently and thoroughly for the purpose of insuring that they are in good condition and in conformance with all applicable requirements these rules.

- Cox's records indicated that from December 2017 through December 2022, Cox completed 529 patrol inspections of its nodes past Cox's scheduled due date.
- Cox's records indicated that from December 2017 through December 2022, Cox completed 4 detailed inspections of its nodes past Cox's scheduled due date.
- Cox's records indicated that from December 2017 through December 2022, Cox completed 480 undefined type of inspections of its nodes past Cox's scheduled due date.

GO 95, Rule 18-B1, Maintenance Programs, states in part:

Companies shall undertake corrective actions within the time periods stated for each of the priority levels set forth below. Scheduling of corrective actions within the time periods below may be based on additional factors, including the following factors, as appropriate ...

GO 95, Rule 31.1, Design, Construction and Maintenance, states in part:

For all particulars not specified in these rules, design, construction, and maintenance should be done in accordance with accepted good practice for the given local conditions known at the time by those responsible for the design, construction, or maintenance of communication or supply lines and equipment.

• Cox's records indicated that from December 2017 through December 2022, Cox completed 8 overhead work orders past Cox's due date for corrective action. Additionally, as of the date of the audit, Cox had 1 open overhead work order that was past Cox's scheduled due date for corrective action.

IV. Field Inspection – Violations List

My staff observed the following violations during the field inspection portion of the audit:

GO 95, Rule 31.1, Design Construction and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

Cox's facilities on the following poles required maintenance:

- Pole P972738 Cox's facilities were incorrectly transferred to the new pole.
- Pole 1055531H Cox's riser conduit was damaged and hanging off the pole.
- Pole P88410 Cox's riser conduit was improperly secured to the pole with a rope.

GO 95, Rule 38 - Minimum Clearances of Wires from Other Wires, Table 2, Case 8, Column C, requires the minimum vertical separation between communications conductors on separate crossarms or other supports at different levels on the same pole and in adjoining midspans to be 12 inches.

The separation between Cox communications facilities and a third-party communications conductor on each of the following poles had less than 12 inches of vertical separation:

- Pole at the intersection of E 20th St. and F Ave. Cox's conductor in contact with another communication conductor.
- Pole 617883H Cox's service-drop in contact with another communication service-drop.
- Pole P375113 Cox's conductor in contact with another communication conductor

GO 95, Rule 31.6, Abandoned Lines, states in part:

Lines or portions of lines permanently abandoned shall be removed by their owners so that such lines shall not become a public nuisance or a hazard to life or property.

A permanently abandoned Cox conductor on each of the following poles was not removed:

- Pole P575251
- Pole P376148

GO 128, Rule 17.1, Design Construction and Maintenance, states in part:

Electrical supply and communication systems shall be designed, constructed, and maintained for their intended use, regard being given to the conditions under which they are to be operated, to enable the furnishing of safe, proper, and adequate service.

- The pedestal in front of 2111 Meade had an unsecured cover.
- The pedestal in front of 975 Roca Place had a damaged cover.
