1.0 INTRODUCTION

This document describes the Practices employed by the Southern California Edison Company (SCE) for the inspection of substations.

2.0 PURPOSE

The intent of these Practices is to help ensure the safe delivery of reliable power in a costeffective manner and compliance with applicable regulatory requirements.

These Practices are based in part upon internal system knowledge, experience, and expertise, as well as accepted Good Utility Practice, and takes into consideration competing influences, such as operating protocols and emergency conditions.

3.0 APPLICABILITY

Facilities subject to the California Independent System Operator's operational control and/or subject to FERC reliability standards and Customer Substations are exempt from this General Order.

4.0 DEFINITION OF TERMS

4.1. Annual

A calendar year.

4.2. Discrepancy

A condition that does not conform to regulatory requirements, SCE's inspection standards or operational requirements.

4.3. Good Utility Practice

Any of the practices, methods, and acts engaged in or approved by a significant portion of the electric utility industry during the relevant time period, or any of the practices, methods, and acts, which, in the exercise of reasonable judgment in light of the facts known at the time the decision was made, could have been expected to accomplish the desired result at a reasonable cost consistent with good business practices, reliability, safety, and expedition. Good Utility Practices is not intended to be any one of a number of optimum practices, methods, or acts to the exclusion of all others, but rather acceptable practices, methods, or acts generally in practice in the region.

4.4. Inspection

A basic visual evaluation of substation facilities for the purpose of identifying discrepancies.

4.5. Station Log

A business record of events occurring within a Station.

4.6. Substation/Station

The secured site or location containing facilities uniquely located and under the control of qualified SCE employees, through which energy is passed for the purpose of switching and/or transformation.

4.7. Customer Substation:

A substation that functions as the main source of electric power supply for a single customer, including those that provide feed through for additional customers.

Customer substations are not subject to the reporting requirements in section 6.1.5.

4.8. Operator

The person qualified by reason of training, experience, and instruction, responsible for inspecting substations.

4.9. Work Management System (WMS)

The interactive database(s) used to collect inspection data.

5.0 RESPONSIBILITIES

5.1. Transmission and Distribution (T&D)

5.1.1. Grid Operations

Responsible for the 24-hour operation of the electric system and substation inspection.

5.2. Generation

Responsible for the inspection of substation facilities in and around generating stations as well as certain substations in remote locations through agreement with Transmission & Distribution (T&D).

6.0 PRACTICES

6.1. Inspection

6.1.1. Scheduled

Each substation should be inspected by an operator based on the intervals listed in Attachment A for that particular substation. The inspection intervals are based in part upon internal system knowledge, experience and expertise, as well as accepted Good Utility Practice. EXCEPTION: Less inspections than specified in Attachment A may be conducted if limited due to reasonable circumstances such as extreme weather (e.g. snow), no access, or system emergencies (e.g. fires, storms, etc.) prevent such inspections from being conducted.

When the operator enters an unattended station an entry should be made in the station logbook. Note: Manned substations do not contain logbooks. Identified discrepancies that require immediate action are communicated to the appropriate supervisor. The remaining discrepancies found during inspections are noted on the electronic inspection forms. Responsible supervisors review identified discrepancies and assign a priority rating.

6.1.2. Unscheduled

Unscheduled inspections may also be performed during routine operational activities such as switching, or in response to storms, fires or other events. The performance of an unscheduled inspection is not typically documented except for entries made in the substation log book and any discrepancies discovered and entered in the WMS.

6.1.3. Facilities

Facilities include: Batteries; Buses; Capacitor Banks; Circuit Breakers; Fire Detection/Suppression (where applicable); Grounding; Insulators/Bushings/Arresters; Perimeter Fencing and Gates; Reactors; Structures; Transformers; Voltage Regulators.

6.1.4. Record Keeping

Records include the following information: Inspector name or identifier; inspection date; and a brief description of identified discrepancies. Inspection records are retained for not less than five (5) years.

6.1.5. External Reporting

Upon request, records and documents are transmitted to Maintenance and Inspection (M&I) Analytics Performance to facilitate required reporting. No later than July 1st of each year, Compliance Integration (CI) transmits to the Safety and Enforcement Division (SED) a report summarizing completed and past due Inspections for the prior calendar year.

Changes to these Practices are noted in the Inspection Program Summary, including the effective date of the change. The report includes any changes made to the Program since the previous report.

6.1.6. External Audits

T&D CI coordinates and leads external compliance audits and serves as a regulatory interface with SED staff.
