Purpose:

The first half of Workshop #5 will discuss the possible adoption of Risk Mitigation reporting templates. Templates could ensure clear utility provision of the information needed to support utilities' risk mitigation programs.

The second half of Workshop #5 discusses the varying discount rates (i.e., dual-rate discounting) for mitigation costs and benefits within the Cost-Benefit Ratios as stipulated by the Risk-Based Decision-Making Framework. Discount rates are used when calculating the present value of risk reduction benefits and mitigation costs to account for the time value of money.

Expected Outcome:

Workshop attendees will provide feedback on the benefits, costs, and any additional revisions related to whether the Commission should provide guidance regarding the use of varying discount rates, whether the Commission should identify an appropriate discount rate, whether the Commission should authorize IOUs to vary their use of discount rates by mitigation, and whether the Commission should require the use of Risk Mitigation reporting templates.
