**Purpose:**

The purpose of this Workshop is two-fold: 1) to discuss any changes needed to the Climate Adaptation and Vulnerability Assessment (CAVA) framework to support consideration of climate change in the Risk-Based Decision-Making Framework (RDF) and, 2) to discuss the issue of climate change with regard to the RDF. In Proceeding R.20-07-013, the Commission, in D.21-11-009, concurred that the issue of climate change impacts, risks and mitigation measures is worthy of consideration. At present, the RDF does not provide explicit guidance for how utilities should reflect climate hazards in their Risk Assessment Mitigation Phase (RAMP) filings. D.20-08-046, adopted in Proceeding R.18-04-019, addresses climate adaptation planning and ordered the utilities to prepare CAVA filings, amongst other actions. To ensure consistency with R.18-04-019, development of any additional guidance regarding addressing climate hazards within the RDF must consider experience with the CAVA as ordered in D.20-08-046. Discussions will also consider more generally how climate hazards should be reflected in RAMP filings. To facilitate cross-proceeding coordination, this will be a joint workshop on the topic of climate change considerations within both proceedings.

**Expected Outcome:**

Workshop attendees will provide feedback on the benefits, costs and any additional revisions related to the explicit integration of climate change into the RDF and RAMP filings.
