Pursuant to Ordering Paragraph 31 of Decision ("D.") 19-01-018, Golden State Water Company ("GSWC"), doing business as, Bear Valley Electric Service ("BVES") submits this Annual Physical Security Report to the Directors of the Safety and Enforcement and Energy Divisions of the California Public Utilities Commission ("Commission").

D.19-01-018 requires utilities to submit an annual report detailing physical incidents from the preceding year resulting in utility insurance claims, all OE-417 reports submitted during the period, and any significant changes to Security Plan Reports.
