**METHODOLOGY:**

Claim notifications to insurers are made in compliance with internal policy notification obligations. Insurers are notified of claims when property damage at insured sites is likely to exceed half of the retention. PacifiCorp reviewed records and determined that no physical security incidents were reported regarding physical substation locations to insurance carriers for the Period April 1, 2020 through March 31, 2021. This would indicate that no physical security incidents occurred specifically at PacifiCorp owned substations between April 1, 2020 and March 31, 2021 where the property damage was likely to exceed half of the company’s insurance retention value.
