Bear Valley Electric Service, Inc. (“BVES”) is hereby submitting its Annual Physical Security Report pursuant to California Public Utilities Commission’s (“the Commission” or “CPUC”) Decision (“D.”) 19-01-018, Ordering Paragraph (“OP”) No. 31.

As required by D.19-01-018, the complete reporting period for this annual report is from April 1, 2020 to March 31, 2021. However, the information reported between March 1, 2021 and March 31, 2021, is provisional, based on information known to BVES by the date of this report. Incidents may have occurred during this period. BVES ensures that any information provided to the Commission goes through a comprehensive verification and validation process, so that the information submitted is complete and accurate. BVES will submit an updated report by May 31, 2021 only if there is any new information to report during the reporting period from March 1, 2021 to March 31, 2021. If there is no new information to report for the remaining compliance period, this current report will be considered the final annual report.

This report is comprised of the following three sections, which address report requirements set forth in D.19-01-018, OP 31 and Section 6.7.

Section 1 – Physical Security Incidents Resulting in a Utility Insurance Claim

BVES did not experience any physical security incidents at its distribution facilities resulting in a utility property insurance claim during the period of April 1, 2020 through March 31, 2021.

Section 2 – Significant Changes to the Security Plan Reports

Per D.19-01-018, OP No. 2, Final Security Plan Report shall be submitted within 30 months of the Decision being adopted, which is July 10, 2021. Since the Final Security Plan Report is not yet due, BVES does not have any significant changes to report at this time.

Section 3 – Summary of Previously Submitted OE-417 Reports

BVES has not submitted any Form OE-417 to the US Department of Energy.
