# Report of Summary of Balancing Accounts For

# Class A and B Water Investor-Owned Utilities For the Six-Month Period Ending December 31, 2022

This is the Semi-Annual Balancing Account Report on the status of balancing accounts<sup>1</sup> for the Class A and B Water Investor-Owned Utilities (IOU) for the six-month period ending December 31, 2022. Pursuant to Public Utilities Code §792.5 (c), the Commission is to maintain an inventory of all Class A and B large Water IOUs' balancing accounts.

## Summary

The total number of balancing accounts for Class A Water IOUs is 114, a decrease of 6 balancing accounts from the corrected number of accounts in the June 30, 2022, report (see Table 1).

The total number of balancing accounts for Class B Water IOUs is 24, no change from the June 30, 2022 report (see Table 1). In addition, the following reporting requirements as specified in the Public Utilities Code §792.5 are included for all the Class A and Bs water utilities:

- 1) Balancing accounts with a Semiannual-end balance with more than a 10-percent differential from the balancing account's authorized revenue amount (Table 3).
- 2) Balancing accounts with an authorized revenue amount that is in the 25<sup>th</sup> percentile of all balancing accounts (Table 4).
- 3) Balancing accounts that have experienced volatile fluctuations in their semiannual balances over time (Table 5).
- 4) Balancing accounts that have not been reviewed in the previous three years (Table 6).

The utility responses to the reporting requirements are listed in tables numbers 3 through 6 of this report. Positive dollar amounts indicate over collected balances and negative dollar amounts in red text indicate under collected balances.

# California American Water Company (Cal Am):

In the last two Balancing Account Reports, Cal Am listed the following two closed accounts that are no longer listed in this Report and that had zero balances:

- 1) Sand City Desalinization Plant Purchased water Balancing Account and
- 2) Monterey Seaside Basin Adjudication Balancing Account.

Cal Am reported incorrect balances in its June 30, 2022 Report on Balancing Accounts for the following accounts:

- 1) Pension Balancing Account;
- 2) Purchased Power BA;
- 3) Monterey WW BA;
- 4) East Pasadena Purchased Power BA;
- 5) East Pasadena Pumping BA; and
- 6) East Pasadena Purchased Water BA.

In this report Cal Am indicates that the correct balances are reflected in the accounts above.

#### **California Water Service Water Company**

California Water Service reported no changes in the number of balancing accounts in this report. However, there was an error in reporting the correct name of the balancing account. Instead of listing Health Cost BA 2015 GRC (HCBA3), the June 30, 2022, report listed Interim Rates (old GRC) Balancing Accounts.

### San Gabriel Valley Water Company

San Gabriel closed one account, the Mains Projects Balancing Account via Advice Letter 580 and transferred the March 2022 overcollection in the PABBA account.

#### San Jose Water Company (San Jose)

San Jose closed the following nine accounts:

- 1) Balancing Account-Pending (2017)
- 2) Balancing Account-Pending (2018)
- 3) Balancing Account-Pending (2019)
- 4) Purchased Power
- 5) Purchased Water 2021
- 6) Pump Tax 2021
- 7) Purchased Water Non-contract 2021
- 8) Purchased Water Recycled 2021
- 9) Amortization of 2018 Tax Memorandum Account

San Jose also opened the following three accounts:

- 1) Balancing Account-Pending (2021)
- 2) Full Cost Balancing Account
- 3) Water Revenue Adjustment Mechanism (WRAM) BA

In addition, there are three accounts that changed names from the June 30, 2022, Report because the account tracked the 2021 General Rate Case cycle:

- Amortization of under collection of various Memorandum Accounts GRC 2021, previously tracked expenses from the prior GRC cycle under the Amortization of under collection of various Memorandum Accounts GRC 2018 balancing account.
- 2) Amortization of under collection of various Balancing Accounts GRC 2018, previously tracked expenses from the prior GRC cycle was previously the Amortization of under collection of various Balancing Accounts GRC 2021
- 3) Balancing Account Pending (2021), previously tracked expenses from the prior GRC cycled under the Balancing Account Pending (2022) balancing account.

### **Suburban Water Systems (Suburban)**

Suburban reported all its balancing accounts as required. Table 2 shows all 15 balancing accounts and reserve accounts for Suburban. There are three new accounts that started recording balances as follows:

- Purchased Power, Purchased Water and Pumped Water, (AL 375 reviewed 8/25/2022 thru 9/15/2022) for San Jose Hills Service Area.
- Recycled Water (AL 375, reviewed 8/25/2022 through 9/15/2022) for San Jose Hills Service Area.
- Purchased Power, Purchased Water and Pumped Water, (AL 375) for Whittier-La Mirada Service Area.

The WRAM Balancing Account for Whittier-La Mirada was shown twice in error in the June 30, 2022 report. As such, the total number of balancing accounts as of the June 30, 2022 report is 12.
