What does D.20-12-007 Authorize for Cal Water?

Utility Revenue – Company Wide (21 Districts):

- Year 2020: \$696.5 million (M)
 - o Increase of \$4.43M (0.6%) above authorized 2019 revenues
- Estimated Year 2021*: \$717.4M and Year 2022*: \$738.8M
 - Increase of \$20.9M (3.0%) and \$21.4M (3.0%) respectively

Utility Revenue – East Los Angeles District:

- Year 2020: \$38.1M
 - o Decrease of \$0.92M (-2.4%) above authorized 2019 revenues
- Estimated Year 2021*: \$38.9M and Year 2022*: \$39.7M
 - Increase of \$0.80M (2.1%) and \$0.85M (2.2%) respectively
